The Wisconsin Association of Food Protection (WAFP) would like consideration for the IAFP Affiliate Education Award for 2019. The affiliate hosted three educational sessions in 2019; HTST Pasteurizer Operations and Procedures certification course on April 2nd, Spring Workshop on June 19th and Fall Workshop held on November 14th. Descriptions of each session are listed below.

The annual Pasteurizer Certification Course co-hosted by WAFP and the Department of Agriculture, Trade and Consumer Protection (WDATCP) had 58 attendees in Monroe, WI. The course included lecturers from WDATCP and the University of Wisconsin-Madison.

The Spring Workshop held in Madison, WI and attended by 75 participants, one of the highest attended events in history of WAFP. The education committee developed the program based on member feedback, building off information from DATCP, CDC, FDA and industry. The program included an overview of WDATCP activities, delivered by Dr. Steve Ingham. James Beix of the WDATCP Rapid Response team presented outbreak responses in Wisconsin and the upcoming Democratic Convention, to be held in Milwaukee, preparation activities. Erika Bognar of Sargento gave a heartfelt presentation outlining the steps to recovery after their 2018 recall. The presentation has the highest rating from our members survey in recent history. Matthew Weis of the CDC gave an overview of CDC activities as related to national outbreaks. To round out the workshop, the presenters sat on a panel and took questions from the audience. The workshop was highly rated and is a format will be visited once again.

The Fall Workshop held in Madison, WI was attended by 51 participants from the food industry. Based off feedback, the education committee developed a broad-spectrum agenda. David Fikes of the Food Marketing Institute gave a code dating update for food products, which was a topic of confusion for many members and was made clearer by Mr. Fikes. Dr. Marielle Weintraub introduced much of the audience to CBD in an overview, outlining the regulatory aspect of

this new product line. Jessica Zetlau of Yum! brands gave an engaging presentation on food safety culture, which has been a topic WAFP has been wanting to bring to cover for many years. Member feedback suggested she will be requested as a speaker in the future. Adam Brock of Dairy Farmers of Wisconsin gave an overview of the New Era of Smarter Food Safety as he had attended the meeting in Washington D.C. to kick off the initiative, which will be important for WAFP members. The 2019 Leadership Award was given to Janet Raddatz, formally of Sargento, giving an introspective speech of her career and advice for new generation of food safety professionals.

Overall, the WAFP Education Committee felt 2019 workshop series was a success. We are taking advantage of the IAFP Speaker Series for Spring 2020 and look forward to having Dr. Mickey Parish.
