Last year, AQIA hold its 1-day annual meeting as a joint event with <u>BENEFIQ 2023</u>, the international rendez-vous on Sustainability in Food and Innovation (6th edition, Quebec Convention Center, Québec, Canada, 600 attendees). Supported by the expertise of INAF, Université Laval (in collaboration with Quebec Ministry of Agriculture, Fisheries and Food MAPAQ and Québec city), BÉNÉFIQ is an important gathering that connects researchers, the bio-food industry, the health ingredients sector, and the entire innovation community.

More than 80 participants, members of AQIA and IAFP, academia, industrials, professionals, government, attended this 1-day conference on October 5th on food safety issues and challenges in relation to sustainable food.

Jeff Farber, IAFP member (University of Guelph, Guelph, Ontario, Canada) was the one of the keynote of the conference program. Lee-Ann Jaykus (North Carolina State University, Raleigh, NC, USA) was among the renown speakers. Many student presentations and a round table on *Enhancing Collaboration Among Diverse Stakeholders for Safety and Innovation in the Context of Circular Economy* involving stakeholders and industrials were also part of the program. A workshop, organized in collaboration with The Consortium for Research and Innovation in Industrial Bioprocesses in Quebec (CRIBIQ), gathered AQIA members and researchers to create and develop new R&D projects in the field of food safety. By bringing together key players from safety and bio-food sector, AQIA showed the important role of multidisciplinary research as a catalyst for positive change in the context of future global challenges (see the program below).
