#### **Old Business:**

- Minutes from 2015 Committee meeting were reviewed and approved by the Committee members.
- Status of 2015 recommendations to the Executive Board
  - Recommend to the Board to appoint Faith Critzer as the Vice Chair of Food Protection Trends Management Committee. Board Response: Approve.
  - Recommend to the Board to reappoint Catherine (Cathy) Cutter as the FPT Scientific Editor a four-year term. Board Response: Approve.
  - Recommend to the Board to check with Allen Pre-publication Reference Checker to check references in journal articles submitted for publication. Board Response: IAFP staff to research the cost and see if it can be used for both JFP and FPT. Use of the correct "EndNote" template can also help.

Update: It isn't feasible for Allen Press to create an Endnote template.

 Recommend to the Board to redefine in the IAFP Bylaws Section V, Part C the definition of FPT to include words such as applied research, information, and member news.
 Board Response: FPT Editor and staff to look into redefining this section of the Bylaws. Then a recommendation would be made to the Constitution & Bylaws Committee to consider the change.

Update: Current Bylaws: Food Protection Trends shall be the applied technical publication of IAFP and the Journal of Food Protection will be the scientific research publication.

Proposed change presented to the membership: Food Protection Trends shall be the applied technical publication of IAFP and will include applied research articles, general interest articles, food safety information and member news. The Journal of Food Protection will be the scientific research publication.

Friendly amendment (to be proposed at the Business Meeting):

- The Association shall have two journals: Food Protection Trends and the Journal of Food Protection. Both publications shall include peer-reviewed, scientific, applied and technical research and review articles. Food Protection Trends shall also publish general interest articles, food safety information and member news.
- The Committee agreed to the friendly amendment. It will first be discussed by the Bylaws Committee before voting on by the membership at the Business Meeting.
- Recommend to the Board to develop a survey to determine if FPT and JFP are meeting the needs of the membership. Board Response: IAFP Staff will look into the cost and determine if the survey should be jointly conducted for both journals or if a separate survey for each is needed. It will need to be determined if the survey has a readership or publishing focus.

Update: This has been delayed because it wasn't appropriate to survey membership on both *FPT* and *JFP* due to extensive changes occurring with *JFP*. This topic was carried forward in a discussion summarized in New Business.

 Recommend to the Board to determine the numbers and usage of articles downloaded from IAFP website by users. Board Response: IAFP Staff will work with the Web developer to obtain additional statistics.

Update: We don't have a current metric for this, but we can get this information going forward. Next year we will have this information to report to the *FPT* Management Committee.

## **New Business:**

- Executive Board report: Mickey Parish, IAFP Vice President.
  - a. 4,100 IAFP members with 3,400 participants in this year's meeting and 175 exhibitors, both records for the organization.
  - b. Board will meet on Thursday to review all recommendations from *FPT* Management Committee.
- 2. Scientific Editor report: Catherine Cutter.
  - a. 2015 was very production 42 manuscripts were submitted, with 32 being accepted.
  - In 2016, 11 papers have been submitted, with four being accepted/3 rejected and the remainders are still under review or revision by authors.
  - Cathy Cutter has been inviting papers for submission after Annual Meeting and this may be a driver for increased.
  - d. A higher rejection rate was noticed, three of 11 submissions in 2016. This was driven by an increased number of members on the editorial board, with an increased breadth and depth of expertise

- 3. A discussion to create an award to recognize a publication in Food Protection Trends occurred. The discussion focused on what the appropriate metrics are to recognize the publication. The FPT Management Committee recommended that data be collected with respect to (1) most viewed; (2) most downloaded; and (3) most cited manuscripts in order for the us to determine what the appropriate metric(s) are to recognize one publication in Food Protection Trends. A formal recommendation will be made to the Executive Board to collect these data for six months and reported back to FPT Management Committee, in which time the Committee will hold a mid-year conference call to determine the appropriate course of action for creating an award to be given at the Editorial Board Reception at the 2017 IAFP Annual Meeting.
- 4. Improperly formatted manuscripts are still an issue with submitted manuscripts. It was discussed that the fines associated with improperly formatted manuscripts be instituted to address the problems. This will be a subjective call by Cathy Cutter and Donna Bahun. A multi-prong approach will be instituted which includes: (1) revised instructions for authors; (2) emphasis in acceptance letters; and (3) an author acknowledgment that formatting is correct during submission online. We will also point out issues associated with the use of EndNote or other citation management software in the instructions for authors.
- 5. A discussion occurred regarding surveying IAFP membership regarding FPT. The Management Committee felt that this would be appropriate and recommended that a subcommittee be formed to determine the objectives for a survey of IAFP members regarding Food Protection Trends. Jennifer Quinlan, Ben Chapman, Francisco Diez-Gonzalez, Faith Critzer, and Cathy Cutter will serve on this subcommittee. A formal recommendation will be made to the Board to allow FPT Management Committee to create a survey tool to be administered to IAFP membership.
- 6. A recommendation was made to engage the young scholars partnering with the Student PDG, Webinar subcommittee, JFP Management with FPT Management to advise them on publishing scientific manuscripts. The members felt that this would be a worthwhile approach and will contact the other partners to see if they are also interested.
- A mid-year conference call will be held in 2017 (roughly January or February) with FPT Management Committee to discuss topics such as FPT publication award and survey tool.

#### Recommendations to the Executive Board:

FPT Management Committee would like to recognize one publication from Food Protection Trends at the Annual Meeting Editorial Board Reception in 2017. It is recommended that data be collected with respect to: 1) most viewed; 2) most downloaded; and 3) most cited manuscripts in order for the FPT Management Committee to determine what the appropriate metric(s) are to recognize one publication in Food Protection Trends. It is recommended that this data be collected for six months and reported back to FPT Management Committee during a mid-year conference call, at which time they will determine the

- appropriate course of action for creating an award to be given during the Editorial Board Reception at IAFP 2017.
- It is recommended that a survey tool be developed for the IAFP membership with the broad goal of obtaining feedback with regard to Food Protection Trends. FPT Management Committee has created a subcommittee tasked with creating this tool and presenting it for approval to the FPT Management Committee during a mid-year conference call, and, if approved, to the IAFP Executive Board.

**Old Business**: Committee reviewed minutes from 2015 *JFP* Management Committee meeting. A motion was approved to accept the 2015 minutes, as written. No edits were needed.

**New Business**: The Committee reviewed agenda and approved the meeting agenda.

The meeting opened with a vote to elect the incoming Vice Chair. Two candidates were up for election by all present members. Sean Leighton was elected Vice Chair for 2017.

Mike Davidson provided the Journal's Scientific Editors' Report. Highlights include that Vol 78 (2015) included 2,312 pages and 302 articles (295 research articles). By comparison, Vol 77 published in 2014 contained 2,232 pages and 295 articles, which included 290 research papers and five review papers. The average length of time between receipt of manuscripts and their publication remained the same in 2015 compared to 2014. Maryland was the most published state within the USA. The editorial board consisted of 159 members, with 46 representing non-USA countries. Ad hoc reviewers were instrumental in the review process. Ninety-one accepted but unpublished manuscripts are currently in queue. While it appears as though the back-log has increased, in reality it is a timing issue, not a back-log issue. Dr. Davidson concluded by stating that the "Most Cited Publication" award was given again this year. A "most-downloaded publication" award was also given. For more details about the Journal in 2015, please see the Scientific Editors' report and the Administrative Editor's report prepared by Didi Loynachan.

Didi mentioned that a \$2,500 open access fee for members and \$3,000 for non-members was approved by the Board and implemented. Nine authors have used this option so far. Our open access policy has been better defined and will be posted on the new website, once it is ready to go up. Indices will no longer be published beginning with this year's volume, relying on keyword searches instead. ORCID can be used to sign-in for authors. The first time ORCID is used to sign in, it will be linked to Allen Track. A document delivery service was also used, entitled Copyright Clearance Center (CCC) Document Deliver Service. This service was acquired from Infotrieve and will continue to provide journal articles through the CCC. 2015 impact factor (IF) was 1.6, total cites are 11,888, the five-year IF is 1.963 and the Immediacy Index is 0.212. A question was asked if the Impact Factor change was significant enough to warrant a formal discussion. Judy will visit in her presentation. A question was asked about subscription numbers. We continue to see a decrease in institutional subscriptions. At one point, we are at 1,500-2,000 and this level continues to go down. One reason that David Tharp mentioned is due to the varying and multiple access points online. This is a trend observed in almost all journals as libraries cut back, etc.

A Scientific Editor search will be conducted this year to replace Dr. Mike Davidson (due to retirement). Dr. Davidson shared some thoughts on how much he has enjoyed his time as Scientific Editor. David Tharp announced the deadline for applications would be September 12, 2016, which is similar to the time frame deployed in the last search process (55) applicants were received last time). A Selection Committee will need to be established to receive and review all submitted information. A teleconference will be held with IAFP and the Selection Committee to decide on the chosen candidate to join as a Co-Editor. The decision will be made and offer extended by the end of October, with the new Editor receiving articles in December 2016. It was proposed that six members will be on the Selection Committee, including the Vice Chair. A request was made for volunteers to fill out the Selection Committee, with one representative from Europe and one from the USA desired. Two volunteers were identified as Sherri McGarry and Xiangwu Nou. Vijay Juneja (Chair) mentioned that he has a couple of names of professors that he will be approaching to represent academia. Elliot Ryser will represent the scientific editors on this Committee.

Judy Luther from Informed Strategies presented a "Progress Report on *JFP*" to the Committee. The objectives of this effort were to (1) Improve the ability of IAFP to better meet the needs of authors, editors and readers; (2) Provide metrics that can recognize the value of published research to multiple communities; (3) Connect the content with global research to increase visibility and Impact Factor of *JFP*; (4) Work with publishing partners who can support ongoing innovation. Ingenta was satisfactory initially, but a change was needed, and other options exist in the market. The enhanced publication process was focused on four areas: Editorial, Production, Platform, and Metrics.

EDITORIAL: How methods papers are identified has been a topic of discussion. Having the word "methods" in the keyword in the abstract would be a good idea to drive consistency moving forward. This will influence discovery via Google Scholar and other discovery methods. With the new system, we can offer a "special collections" link on the web site. This allows us to gather and organize articles on a key topic and feature them for readers. PRODUCTION: Articles

will be released as they are completed and reviewed as opposed to on a fixed cycle. If we invoice on acceptance, we could receive payment at the same time as production. Didi mentioned that when you find an article on the new site, it will automatically recommend other articles. Barbara Ingham mentioned this was a really nice feature from the academic/ author perspective. A process for expediting articles that are time sensitive is being considered. Scientific editors could identify papers that are time sensitive, or authors could request a particular paper be considered for expedition. ORCID identifier is critical for international access. CrossRef will automatically match and link an author's articles. Cited by linking means when you are reading, you can see other articles that reference it. It is recommended that Journal of Milk and Food Technology articles from 1967 to 1976 be accessible online at no cost to subscribers. PLATFORM: Consolidating with Allen Press, which uses Atypon technology in their Pinnacle platform. HighWire has new investors, with two of the larger customers leaving (Sage Publishers has gone to Atypon and Oxford University Press has moved to SilverChair). Consolidation of the workflow allows for an expedition of some of the enhancements we've discussed. A new JFP test site was shared with the Committee and multiple innovations highlighted. METRICS: JFP's Impact Factor is 7th highest in competing journals. ASM decided not to post its Impact Factor this year in an attempt to drive the right behavior behind the use of an impact factor. It is ASM's belief that the IF not be used to rate a journal and that it has become over-dominant as a metric. JFP's impact factor has fluctuated between 1.5 and 2 over the past several years. Judy stressed that the IF is an extremely lagging indicator. Altmetrics.com offers blog, social network and press access and is widely used by publishers. Proposals have been submitted by both Altmetrics.com and Plum Analytics. A list of indexes that are referenced on the IAFP website was shared. It was recommended that "Navigator" and "DigiTop" be added.

The following recommendations were made: (1) Create "subject collections" of existing articles on hot topics; (2) Conduct a discovery audit to confirm that JFP metadata is reaching indexing services and appearing in the literature; (3) Implement Altmetric.com; (4) Evaluate Peer Track and Allen Track. It was requested that Committee members share any additional ideas with Didi, should they have them. Feedback was received that we should be sensitive to changes to the online platform and how they could affect users that are accustomed to the more traditional ways of viewing and accessing information. A discussion was had around methods papers. Some methods papers aren't easily identifiable by simply searching the title or abstract, so leveraging keywords would help. Alejandro asked about the possibility of a marketing strategy. A question was asked around the timing of some of these changes - it is anticipated that all content will be up on the new site by the end of the year. With all the moving parts, we need to ensure the transition is as smooth as possible for everyone. Didi is going to work with Allen Press to confirm the timeline so it can be effectively communicated. The communication and marketing strategy should be reviewed and designed for maximum impact and visibility. As ASM has moved away from the Impact Factor, it was discussed what the appropriate metric is. The balance between selectivity/ quality and volume need to be considered. Selectivity could be reflected by measuring the rejection rate a particular journal exhibits. A higher rejection rate could suggest selectivity is

higher. Judy believes that the Impact Factor won't disappear as a metric anytime soon, despite ASM's stance. A comment was made that some academic institutions insist on students publishing in journals with impact factors greater than 2.0. Judy commented that there is a growing gap between research occurring and the relevance to the general public and the impact factor doesn't necessarily reflect the adoption by a wider audience. She commented that "books, journals and everything else" is now "Books, Journals, data sets and everything else." Alejandro mentioned that the impact JFP has specifically on the food industry is guite significant and may not be reflected in the IF. A long discussion was had on how this could be better reflected, shared or measured to track the journal's relevance and perhaps to contribute to the marketing effort. A comment was made that asking authors to reference previously published JFP articles could strengthen our IF. The future is most likely going to move toward an IF for an individual article vs. a role up/average of all impact factors for a particular journal. We believe JFP is positioned to benefit from this approach.

A motion was approved to recommend a marketing and communication strategy for the *Journal of Food Protection* to the Executive Board to support the output of Judy Luther's work.

## Recommendations to the Executive Board:

- 1. The Committee recommends that Sean Leighton be appointed to Vice Chair of the Committee.
- The Committee recommends that the Board consider and support recommendations that have come out of Judy Luther's approach.
- 3. The Committee recommends that the Board support the development of a marketing and communication strategy to drive the timely promotion of the *Journal*. We recommend the allocation of resources to support the involvement of a marketing/communications specialist to lead this effort.

#### **New Business:**

- 1. Introductions of those attending (Ewen).
- Statement read from IAFP regarding acceptable activities in Committees (Judy).
- 3. Two items added to agenda Secretary Tim Jackson with an update from the IAFP Board and approval of 2015 CCFI minutes. Tim indicated there are 3,400 attending this year. Usually half the symposia are accepted. For symposia, speakers should be given 30 minutes including questions. Review of 2015 minutes: add Jane Van Dorn to last year's minutes. Jack moved acceptance. Ben Tall seconded/moved. Agreed.
- 4. Review of symposia/roundtable for this Annual Meeting (Ewen, Judy, Jack):
  - "How Do We Measure the Effectiveness of Regulatory Food Safety Programs?" Tuesday, August 2, 1:30 p.m. to 3:00 p.m.
  - "Approaches to Safe Use of Irrigation and Wash Water in the Face of Increased Global Water Shortages" Wednesday, August 3, 10:30 a.m. to 12:00 p.m.
  - "Integrating Food Safety into Food Security"
     Wednesday, August 3, 8:30 a.m. to 10:00 a.m.
  - "2016 Foodborne Outbreak Updates"
     Wednesday, August 3, 1:30 p.m. to 3:30 p.m.
- 5. Progress of the Procedures to Investigate Waterborne Illness manual. Ewen indicated that he and Marilyn Lee had been working with Springer (publisher) on the proofs since last August. Springer says it is ready to go out but not yet seen by IAFP staff. In fact, it was for sale at the Springer booth. The format is similar to the Foodborne manual. CDC is aware of the new edition having contributed to it. There was discussion on the use of the manuals. The 2011 Foodborne manual is not identical but consistent with the Council to Improve Foodborne Outbreak Response (CIFOR).
- 6. There was discussion of the need to revise the *Procedures to Investigate Rodent-borne and Arthropod Illnesses* manual although Board approval has already been given. We will check the NIH on-line manual, and other publications. If we proceed, Judy is tentatively willing to coordinate the project (permission from Public Health Agency of Canada, PHAC, required); members and experts to work on different sections need to be identified, e.g., Robbin Lindsey and Nick Ogden of PHAC. There may be a link to One Health, e.g., Jean Kamanzi of FAO, previously the World Bank, and Laura Kahn of Science and Global Security, as well as Lyle Peterson of CDC at Fort Collins.
- 7. Viral and parasitic portions of Diseases Transmitted by Foods Manual (3rd edition) completed but need to be added to the table. Individuals need to be identified to contribute to biotoxin, plant toxicant, and chemical sections. Relevant PDGs will be contacted.
- The 100 Year History of the Committee remains to be submitted to Food Protection Trends requiring agreement between the authors on format.
- The traditional structure of the CCFI has been focused on publication of manuals, but there is no PDG on epidemiology. This currently comes under the CCFI looking to raise issues on surveillance and prevention and control of foodborne disease.

- Should there be a focus to get more visibility for epi at CCFI? Having more FSIS/CDC membership would help.
- 10. For those who wish to attend other PDGs, there was a suggestion that the symposia discussion begin at the start of the meeting and have discussion on manuals later in the day but that also has issues since these are important long-term commitments to the Association.

#### 11. Future symposia:

- International food safety symposia with speakers from countries not previously presented at IAFP is one symposium idea. Since Africa is one region not well represented in food safety issues at IAFP, we will check out the African Affiliate meeting on Tuesday for input, but travel funding may become an issue.
- 2. The International PDG raised the issue of how do developing countries respond to the new FSMA requirements for export. Lebanon with potential Salmonella of tahini affecting export could be one talk. Irshad Sulaimanand (FDA), Don Zink (formerly with FDA), and Osama EI-Tawil (Cairo) may have potential speakers. Israel revised all its food safety regulations as a result of FSMA (Phyllis Posy). China also has new safety laws as a result of FSMA.
- Harmful algal blooms and associated health problems, perhaps combined with seafood pathogens (bacteria, viruses and parasites).
   Contact Water Safety and Quality and Seafood Safety PDGs. Note: cyanobacteria covered at this Annual Meeting.
- 4. Exploring food safety myths in a roundtable format with a panel of Past Presidents (if sufficient "myths" can be identified, a second session could be considered for 2018): Examples of these are: the five-second rule; concerns over GMOs (e.g., soybeans and corn); safety of longterm stored raw milk cheese; avoiding rewashing prewashed greens; counter time until leftover hot food goes into fridge: rinsing meats before handling; washing produce with soap and water not safe for consumption; eating raw shellfish; safety of farmers' markets (food is inspected); safety of sushi; does alcohol kill food pathogens, e.g., raw or eggs oysters in a shot glass; smelling food to see if safe to eat; are brand name products safer than generic products; pink chicken from bone marrow; effectiveness of restaurant signage (competency of inspectors, reliability of inspections, competing issues within department, increasing the risk of bribery, but an incentive to inspectors). There are also industry myths, such as safety of raw milk cheese that is over 60 days old (i.e., blue cheese); flour and pastry for baked goods; industry personal knowledge of their brand products can trump the need for challenge studies to guarantee the safety of their products.
- Root cause analysis of outbreaks: what is it and how is it being used? With three speakers representing outbreak investigations (Vince Radke), regulatory programs (CFSAN or FSIS), and industry (TBD). The term 'root cause anal-

- ysis' is being used more often in the context of food safety but it likely has many different meanings depending on who and where it is spoken of. This symposium will explore the use of root cause analysis in the food safety world and discuss the need to harmonize the meaning to mitigate confusion about the term. This will include a review of the National Environmental Assessment Reporting System (NEARS) with restaurants/retail linking epi data to environmental investigation for 2014 data. Vince Radke will check out CDC sources including Art Liang. Ian Williams and Rob Tauxe (lab, Peter Gerner-Smidt/John Besser at CDC and Eric Brown at FDA and epi, Ian Williams). State local and broad CDC and perhaps another country -Europe – EFSA? Jack Guzewich (former FDA) and Melanie Harris at Department of Health, lowa may also have input. There are plans to have a conference call in August.
- Late-breaking foodborne outbreaks should be an automatic symposium with ideas during the fall but leave one slot for a really late-breaker.
- 7. The mechanisms of immunocompromised (IC) illness, do IC individuals become more likely ill or more severely ill (or both). What is the impact of antacids, limited food intake? Could spores of *Bacillus cereus* in meat loaf affect IC people more than healthy adults since spores are often present in cooked foods? *C. difficile* is found on meat and may be ingested but seems not to cause illness to health individuals.
- 8. Social media to detect outbreaks at federal/ state/local levels. Walmart (Melanie Harris) is looking at CIA software for anti-diarrheals through social media to track enteric illnesses and outbreaks. There could be pings for specific geographical areas. They are also tracking employees calling in ill and where they work at store level. This is in the initial stages, and they are still working on what do you do when there is a spike. New York State uses Yelp and CDC uses Paliter from DND with a focus on norovirus right now.
- Source attribution for Campylobacter cases since we have limited data on the degree which potential sources apply. Michael Batz is willing to work on this one.

#### Recommendations to the Executive Board:

- We seek the Board's input to have a late outbreak symposium at each Annual Meeting with flexibility with at least one speaker slot to be filled within weeks before the Meeting
- We recommend that Marilyn Lee receive an award for her leading role in the publication of the 3rd edition of the Waterborne manual.
- We recommend a conference call in August with several members to discuss a symposium on root cause analysis.

One member suggested we contact members who are not present, especially those who have been absent for the last few years, to determine if they are still interested in sitting on the Committee, and if not, could they recommend someone else. Susan Linn volunteered to contact them.

**Review of Minutes from 2015 Meeting.** Motion to approve was passed unanimously.

## Report from IAFP Executive Board – Mickey Parish.

- The organization is doing very well. The number of membership, attendees and exhibitors is increasing. The organization continues to grow despite other organizations not doing so well. The greater demand for food safety might be the driving force for this increase. Questions raised were: Do we understand why we are growing? Do we need to understand why we are growing? What can we do to continue growing? How big does the association want to become? The goal is to continue meeting the needs of the members and not become an advocacy group or take a position on any issue. IAFP is a place for discussion.
  - Membership in Canada and Mexico is decreasing slightly.
  - Slight decrease in sustaining membership, which could be due to consolidations.

 Discussion: What are the needs from Canadians and Mexicans that are not met? IAFP primarily focuses on American issues (e.g., FSMA but not Safe Food for Canadians Act). Might want to develop a symposium related to Canada and/or Mexico specific issues.

#### **Old Business:**

• Short one-minute video testimonials from IAFP members to help retain members and/or attract new members. Videos should be posted on IAFP website and/or YouTube channel for IAFP. The YouTube channel would need to be tagged with Food Safety, Food Protection and any other relevant tag. Only add top 10 videos to prevent overloading the channel. Highlights from the Annual Meeting (e.g., slide show with pictures) could also be added on the YouTube channel. Need to propose this idea to the President of IAFP.

#### **New Business:**

Increasing membership numbers.

- Need to increase membership and attendance of inspectors/auditors/sanitarians. Possibly start a PDG for inspectors/auditors/sanitarians. Another possibility could be a pre-meeting workshop on inspection which could be of interest for inspectors/auditors/ sanitarians but also industry employees. Travel awards could incite these people to participate at the meeting. We might need better advertisement to attract this group of people.
- Metrics could be used to determine how to retain and/or attract members. Conducting a survey of: (1) current members to help determine why they are members and what their needs are, and (2) past members to determine why they left and what can be done to get them back. There may be some costs involved or a free survey platform (e.g., Survey Monkey) could be used to generate a simple survey. Care should be taken when preparing the survey to ensure the questions are asked correctly and will provide the proper information. The format should remain close-ended questions. Input from survey experts might be required.
- Set up a Food Safety Consultant service within IAFP. The service would be interactive and could either be available as part of the Annual Meeting app or through the IAFP Web site. Alternatively, it could be a computer set up at the IAFP meeting or experts available throughout the meeting for face-to-face discussions. A list of experts who agree to help would be developed. Need to consider liability. Also need to consider competitive issue with consultant firms who are members of the IAFP. Logistics remain to be discussed and decided.
- Get IAFP Affiliates to help attract new members.
   A prize/award could be given to the Affiliate which recruits the most members per year. There are concerns regarding the difficulties in tracing members that register through Affiliates. It was suggested to have the Affiliates record the names of the new members and send these names to someone at IAFP for confirmation.

- Consider working with a membership consultant.
   There will be a cost involved. Alternatively, consider reaching out to other organizations (e.g., Women's Food Service Forum) to see how they've managed to increase their membership numbers.
- Currently, there is an explosion of genomics which is leading to a clash between science and law. A symposium, roundtable or workshop could be organized to expand on the current knowledge and practices, and attract new, non-traditional members (i.e., food lawyers).
- Another important topic is the amount of food being wasted because of best before dates.
- A workshop was suggested to help new members (e.g., new graduates) of the food safety community learn how to establish themselves in the food industry. The rationale being that new members will continue renewing their membership and grow with the association. Also, new members could potentially convince their supervisors to send more people for training at the IAFP.

#### **Recommendations to the Executive Board:**

- Increased symposia related to Canadian and/or Mexican issues.
- 2. IAFP should get a YouTube channel to add content and help advertise.
- Development of a new PDG for inspectors/auditors/ sanitarians (though there is concern that there are too many PDGs already).
- A survey should be developed to capture metrics on why members are staying with IAFP and why past members have left.
- A Food Safety "Ask an Expert" service should be established at the IAFP meeting.

Dr. Siragusa requested PDG members sign-in (or be scanned) and non-PDG members to sign-in and register as a PDG member via the IAFP Web site. - Discussion: Ideas, Concepts and New Business
- Symposia, Roundtable, Workshop Ideas for Proposals for IAFP 2017; due October 4, 2016.
- NGS bioinformatics training at IAFP 2017 or yearround training courses.
- Greg Siragusa asked by show of hands how many people in the room were bench scientists actively collecting and using NGS data – approximately 20 people raised their hands.
- Forming and selecting a team of traveling lecturers to visit branch meeting and deliver lectures on important and vital topics. Call it the IAFP Foundation Distinguished Speakers (similar to ASM Foundation Distinguished Speakers).
- Student Involvement in our PDG (a PDG presence at the student luncheon would be a place to start).
- By show of hands approximately a dozen attendees were potentially looking for employees with PDG-focused skillsets. Greg Siragusa asked how this PDG might help – no discussion on topic.
- Melody Thompson (Cargill) provided an industry perspective and opening a discussion on the best ways for industry to implement NGS technologies and use NGS data. The topic focused on regulatory issues, how the data will be used, data sharing, and associated legal issues. When asked by show of hands, approximately six people in attendance were currently collecting and using NGS in production and processing. Greg Siragusa suggested a conversation with Bill Marler on his perspective on what a sequence alone (in the absence of an isolate) would mean in foods.

- The topic of a side-by-side comparison of proficiency testing of PFGE and GeneTrakr. This could help push the labs toward sequencing methods. The topic of genomic methods in the BAM was mentioned
- Greg Siragusa brought up the topic of detection of DNA from dead or non-viable organisms, particularly with regard to zero-tolerance organisms. A discussion from Pratik Banerjee and others centered around the use of gene expression data (RNA Seq) and DNA sequencing data to confirm the presence of a live organisms, as well risk assessment variables with finding DNA from a dead or non-viable organisms.
- Questions and items discussed from the membership:
  - IAFP Foundational speaker program (similar to ASM Distinguished Speakers).
  - Industry perspective on collection, application and sharing of NGS data.
  - Proficiency testing for FDA GenomeTrakr (sideby-side comparison with PFGE).

#### **Interactive Discussions**

USDA-FSIS Updates: Emilio Esteban summarized the ongoing whole genome sequencing efforts at the U.S. Department of Agriculture and the efforts to identify and characterize every pathogen isolated from meat, poultry, egg products and catfish (domestic and imported) by 2017. He also described the chemistry efforts to continue the collection of data on heavy metals, drugs, pesticides, and antimicrobials. A revised enrichment medium with a neutralizing agent has been implemented by FSIS in the collection of samples for pathogen testing and for baseline studies. The Microbiology Laboratory Guidelines are not changing, only the formulation of the medium for sample collection has been update. The agency is moving to a universal enrichment for pathogen detection and a continuous flow from research to regulatory testing.

Canadian Microbiological Methods: Martin Duplessis stated that in Canada the Compendium of Analytical Methods has the protocols for seven pathogens as of March 2016 and is available on their web site.

**Method Validation ISO 16140**: Pamela Wilger reviewed the efforts on Method Validation ISO 16140 and mentioned that the ISO representing organization in the USA, ANSI, is looking for different technical experts.

STEC Detection Methods: Peter Feng provided an update on STEC detection methods and which genetic determinants are used to make regulatory calls for public health risks. Presence of specific virulence genes, along with stx variants, and serotyping are critical components of how different regulatory agencies (FDA, EFSA, FSIS, CFIA) take regulatory action.

Norovirus Method Update/NoroCore: Lee-Ann Jaykus provided an update on cell culture model to propagate noroviruses recently developed by Mary Estes. She also reported on a recent study that looked at prevalence of norovirus in airplanes and restrooms; 1% prevalence found in restrooms. In addition, norovirus was found to be aerosolized in vomitus from infected people. Lastly, she updated the membership on a recent comparative study on the effect of disinfectants on norovirus as well as the Tulane virus to be uses as a surrogate for norovirus.

STEC CAP Grant Update on STEC Methods: Rodney Moxley provided an update on the USDA STEC CAP grant. He outlined the five objectives of the grant that included PCR based detection assays, development of biosensors, the utility of the Possé differential agar, use of other agars for STEC isolation, and NEOSEEK testing.

Pathogen Testing in Meat Industry: Melody Thompson presented an update on pathogen testing in the meat industry.

Enterotoxins: Sandy Tallent spoke about efforts to harmonize methods to detect enterotoxins from certain pathogens. Part of this process is based on ISO methods with new pre-enrichment broth changes. She also noted that certain methods, such as Tecra kit for *Bacillus cereus*, have been eliminated and now use VITEK. Other companies now have revised their kits (BioControl with AOAC validation study underway) and bioMerieux has introduced a new method.

Comments made on the type of symposia for 2017 include:

- Methods validation.
- Understanding how Listeria survives in the environment and how transient versus resident strains can be identified.
- Universal enrichment broths.
- Low-water activity foods and the selective agents in media (antibiotics) that may stop growth of target organisms.
- Recovery of injured cells and discussion on weather anaerobic or aerobic incubation is better for isolation of facultative aerobes.
- Micro data management.
- Variability of results among automated methods.
- · Detection of live vs. dead cells.
- Metabolites or markers top detect the presence of pathogens in samples.

  - Microbial modeling Risk modeling PDG could possibly have interest in this session.

  - What are the root causes of unexpected situations where allergens could be present because of supply chain cross-contamination?

**Old Business**: Zhinong Yan, Ph.D., Director of Food Safety, Asia Pacific for Ecolab, stepped down as Vice Chair due to his new responsibilities in China. Yan will continue to be a significant IAFP contributor and be very active in our PDG.

## New Business:

- Yale Lary opened the meeting and presented an overview of the Anti-Trust Guidelines. All attendees introduced themselves.
- President-Elect Linda Harris spoke to the PDG as a representative of the Board:
  - PDGs are very important to the function of the IAFP.
  - Largest exhibit hall, largest number of exhibitors, and 34 new exhibitors.
  - Symposia and half-symposia are standardized to 30-minute talks per speaker.

#### Three Short Presentations

- 1. Condensation Management Film Ken Davenport.
  - Condensation is not just a cleaning problem, but a food safety problem.
  - 3M Condensation Management Film disperses water using micro-replicated tapes.
  - Is used around overhead pipes, the tape reduces condensate.
  - Replace the tape quarterly to prevent potential of harborage.
  - Although 3M makes no claims, studies have shown the tape doesn't support bacteria because it is so dry.

## Suggestions/Questions

- Jeff Kornacki what is the build-up of microbes over time?
- Fred Cook do you have color indicator for wetness?

- Dale Grinstead any studies on cleanability of the bigger surface area this product produces?
- Is there a distance from food surface contacts that this can be applied? Deferred to Steve Swanson.
- 2. Hygienic Design for Cleaning Brushes Deb Smith
  - Most brush designs on the market are very un-cleanable.
  - Used fluorescent markers to analyze cleanability of various commercial brushes.
  - Cleaning equipment itself a major source and vector of cross-contamination.
  - 47% of cleaning equipment/utensils had Listeria three times higher then what was expected to be found in drains.
  - Brush-decontamination procedure typically dumping in a bucket with sanitized water and not in-between each bristle and specifically in the drill holes is where harborage occurs.
  - Vikon designed its own fully-molded, shaped bristle design that is more cleanable.

## Suggestions/Questions:

- Listeria testing collaborations demonstrating cleanability from micro standpoint.
- Apply this technology to produce "roller brushes" (ex. Apples).
- 3. LeeAnn Jaykus with NC State University provided an update on the NoroCore Project:
  - The NoroCore Project is a \$25 million grant through USDA NIFA. NCSU is the lead institution with more than 15 partner institutions and many stakeholder groups.
  - Focus on foodborne virus on Human Norovirus divided into six areas:
    - Molecular Virology.
    - Detection.
    - · Epidemiology and Risk Analysis.
    - Prevention and Control.
    - Outreach and Education.
    - Building capacity/education.

Items of recent output from this project will be discussed in detail at the IAFP meeting but the following were briefly described:

- An environmental survey of the public restroom showed evidence of norovirus contamination, prevalence.
- The importance of the food handler in transmission of foodborne norovirus has been confirmed by CDC.
- A mathematical model to estimate norovirus transmission/contamination has been developed and can be used for risk assessment purposes. Healthcare is the first venue to which it will be applied.
- The NoroCore team is developing editable guidelines for recommended methods to clean and disinfect after vomiting and fecal contamination events.
- NYU is developing an "app" for public reporting of gastroenteritis symptoms that will be beta tested in public schools.

- A few questions were posed relative to norovirus transmission, sanitation and disinfection followed by brief discussion.
- Ken Davenport has agreed to complete the Vice Chair term vacated by Zhinong which ends just prior to the 2017 Annual Meeting. However, Ken will be unable to serve as Chair at IAFP 2017 since he is currently the Chair of the Food Packaging PDG, up to IAFP 2018. Vanessa Cranford has agreed to serve as Chair, beginning at the 2017 Annual Meeting, and Ken will serve as Vice Chair.

#### Development of Ideas for IAFP 2017

- Our PDG had active back-and-forth discussions of ideas
- The majority of our members were engaged with the discussions and volunteered to help with the various proposals.

- Tim worked also with IAFP colleagues, Atef Idris, Betsy Bihn, Nathan Anderson, and Mary Lou Tortorello to organize a round table symposium "Food Safety vs. Food Availability: Do we have to choose?" which had panelist Shaun Kennedy, Bob Buchanan, Michelle Smith and Mieke Uyttendaele and Atina Diffley, a farmer, writer, and trainer for farmer and growers. The roundtable generated a rich dialogue that led to the publication of a paper in Food Protection Trends, with the same title as the roundtable. (Food Protection Trends, 2016, Vol. 36, No. 1, pages 72–78.

- Efforts to address the obesity epidemic, reduce chronic diseases (now appearing more and more in children) and eliminate health disparities are focusing on improving access to healthier, fresher, foods such as whole grains, fruits, vegetables, and lean protein sources and so the importance of food safety is heightened at all points of the food production system at which foodborne illness risks can be controlled or minimized. Both food access and food safety also encompass economics, policy, system and environmental factors, social and cultural issues that go far beyond the food supply alone. Safe and nutritious food is a basic individual need and both food safety and food access/availability/security are needed to protect and improve human health. If they are better integrated in a systems approach the food system, globally to locally, as a whole is improved.
- Tim invited members to collaborate on a symposium in 2017 that would explore the intersecting and sometimes conflicting objectives of the various sectors and disciplines that interface with the food system.

Christie introduced IAFP Board Liaison, Tim Jackson who provided updates:

- JFP online will be up and running by December 31, 2016.
- The Program Committee feels that symposia with a maximum of three to four speakers are more effective and allow for a more thorough coverage of content. There will be approximately only 79 slots available in 2017 for sessions. Tim stressed to look for opportunities to collaborate with other PDGs on sessions.
- Workshops and webinars are other great options that have been successful and can be done throughout the year. They are a good way to educate and communicate with a broader audience.
- Tim requested that members start a list of award candidates so that they have a head start if moved to nominate a colleague when the call for awards arrives.

Tim thanked members and expressed that PDGs are the life-blood of IAFP!

New regulatory paradigms under FSMA "Where the rubber meets the road" A conversation about how regulators are partnering with industry on implementing FSMA a year later. FDA and industry sharing lessons learned nationally and internationally.
- Tim Jenkins, Atef Idris, with Produce PDG: Healthy Food, Safe Food, Sustainable Food System. Examine the intersections between nutrition, food protection, and food system sust-

- ainability and discuss actions that IAFP and respective fields could take to advance collaborations and solve problems created by conflicting objectives.
- Atef Idris, Elise Forward: How to better implement food law in developing nations with FSMA now in place. Building the regulatory infrastructure needed from regulators, to trainers, lawyers, laboratories, traceability, surveillance, etc. Creating food Safety agencies that can succeed in the developing world. Considerations/suggestions from members:
  - Outreach to people in other parts of the world who can't travel to IAFP.
  - Collaborate with the pre-harvest group in the interest of increasing the quality and safety of produce from global sources.
  - Explore the process of going from global rules to FSMA standards.
  - Compare developing nations to the U.S. regarding implementation of standards.
  - Collaborate with international affiliates.
  - Cover each government's right to establish food law. Codex is used the absence of food law as the minimum standard. FAO helps the countries that need assistance establishing food law.
  - Cover the resources and organizations to which nations have access to establish a food safety system and standards.
- Bob Buchanan: Agricultural Law, University of Maryland law school is developing programming in agricultural law with the issuance of produce safety rules. Introduce the agriculture lawyers who are used to working with farmers to the food lawyers who are not used to working with farmers.
- Request from the Dairy PDG for Food Law to sponsor a session on trends in Dairy Regulations. Vice Chair of the student PDG would like to collaborate. Student PDG is interested in artisan cheese safety/regulations.
- New member: Explore Trans-Pacific Partnership (TPP) & Transatlantic Trade and Investment Partnership (TTIP) (https://www.brookings. edu/2015/05/20/tpp-ttip-key-trade-deal-terms-explained/) in regard to the harmonization of food regulations between trading partners. Examine European standards vs. U.S. standards.
- Caroline DeWaal, Brigitte Cadieux, Atef Idris and other members: Development of New Frameworks for International Alignment national food safety/control systems. Safe Food for Canadians Act, Australia, Mexico, etc. Members suggestions/feedback:
  - Responsibility for FMSA compliance is with the importer. Foreign supplier verification is a business-to-business relationship but alignment of foreign governments is important to consider.
  - Compare multiple nations that have done or are in the process of food safety modernization
  - IAFP is ideal to facilitate the dialog and discussion.
  - International PDG is a suggested partner.

Additional idea for education and outreach from Caroline DeWaal: Food Law PDG members published a series of seven articles on FSMA in 2014 and now that we have FSMA in place, the articles could be updated. IAFP has a web page specifically for the articles that break FSMA down for professionals.

Food Safety Modernization Act: A Series on What is Essential for a Food Professional to Know. The U.S. Food Safety Modernization Act (FSMA) is a significant and far reaching update of the laws and subsequent regulations that affect the safety of domestically produced and imported foods regulated by the Food and Drug Administration (FDA). Through FSMA, the U.S. Congress provides the FDA with greater powers and direct it to develop regulations that will focus the food industry on the prevention of foodborne illness. - Carol Wallace introduced herself as Chair of the PDG and welcomed existing and new members to the PDG and ran through the agenda for the meeting.
- Apologies were sent on behalf of Brita Ball (Vice Chair).

- Preliminary general announcements made.
- Carol reviewed the antitrust guidelines, and discussed the function of the PDG to be a forum of sharing.

### Report from IAFP Executive Board:

- No Board/staff members present to deliver report from the IAFP Executive Board. Board Representative did join meeting later but unfortunately timing was such that it wasn't possible to build in report.
- Carol informed the PDG that the Annual Meeting was expected to be another record breaking attendance.

### **Old Business:**

Update from last year:

- As part of the 2015 PDG, the attendees broke out into smaller workshop groups – consumer, industry and academic – to discuss issues and ideas relating to food safety education. The session raised ideas of roundtables and symposium suggestions. This resulted in a number of sessions put forward. PDG supported a number of other ideas from other PDGs. Good level of success of items accepted that were put forward by the PDG.
- Two proposals supported by the Food Safety Education PDG were successful, including:
  - RT6. How to fix food safety education and and enhance training effectiveness.
  - S51. An international perspective on the development of targeted food safety education for vulnerable populations.

#### **New Business:**

## **Vice Chair Vacancy**

- a. Call for a Food Safety Education PDG Vice Chair to begin serving at the IAFP 2017 PDG meeting had previously been made to PDG members with the notice of the meeting. Following expression of interest, one nomination was received. Carol opened the call to the floor; no further expressions of interests were made. Francie Buck was the sole nominee.
- Francie Buck was invited to address the group.
   Francie works with Sealed Air with 15 years' experience including food safety training.
   Discussed ideas for symposium and previous roundtables, gave insight on how roundtables can be successful. Carol suggested that PDG forward Francie as future
- Following a show of hands and no objections, the motion was carried.

**Guest Speakers:** Presentations on topics of interest to PDG members relating to food safety training of employees and education of consumers.

- Bertrand Emond Presentation on the Campden BRI Food Safety Training Survey.
  - a. Global Food Safety Training Survey 2016.
     Conducted over the last four years, believed to be the largest food safety training survey, goes

- to 25,000 sites world-wide with BRC, SGS, SQF and TSI as an identified need for benchmarking. (Response rate for 2016 survey n=1,500). The survey on the training of employees in the food industry included SME to large businesses and included all sector categories and included global respondents 35% USA. The Data obtained from the survey provides invaluable information that enables businesses to benchmark their food safety training against other food manufacturers and processors from around the world and identify opportunities for develop- ment of training and education in the food industry.
- Perceived FS training function only 8% believed it to be the responsibility of human resources, suggesting that many companies are not exploiting the specialist expertise available in their HR departments. Traditional training methods are still favored over online methods as the majority of training was reported to be 'on the job,' findings suggested that computer-based learning is not highly used for the training of employees in the food industry, suggesting that food businesses are not integrating with new technologies. Self-reported training hours varied between employees and managers; suggested that lack of training but also that training activity is often underestimated. Personal hygiene most frequently included in training. Main training deficiencies included lack of understanding by employee and lack of refresher training. The understanding/impact of training was reported to be assessed by methods including records of attendance and successful completion of guizzes. Behavior is measured by internal audit programme. Further to lack of computer based training, the survey determined greater reliance on paper based management of training records than excel spreadsheets. The majority of businesses have formal annual training plans. Cumulatively, management were perceived as having responsibility for the food safety training of employees in the food industry.
- The survey identified that the training goals of many businesses were to improve the food safety culture of the organisation and increase effective employee engagement in the workplace. Completion of the survey suggested that food safety training in the food industry needs to be relevant and current. The perceived benefits of training were improved product quality, improved food safety culture and fewer food safety incidents. Challenges for training were identified to be a lack of resources and lack of culture. Biggest challenges were recruitment. The survey also established that people entering the food business may not have sufficient food safety training. Indeed, equipment suppliers staff do not receive food safety training. Time is the greatest challenge in relation to food safety training in the food industry. Consequently the research concluded that 54% believe there is a need for the development of a Food Safety training standards.

- d. Following a question from the floor regarding the tracking of differences in responses year-to-year, Bertrand reported that despite in-depth analysis, no significant changes year-to-year have been identified with regards to perceptions and self-reported training efforts, thus suggesting the potential need for the development of the food safety training standard.
- e. Following a question from the floor regarding the exclusion of countries with developing economies, Bertrand discussed that differences would be expected between developing and developed countries. However acknowledged potential bias in responses due to inclusion criteria of recruiting businesses through partners including food industry members of SQF Institute, BRC, SGS and TSI, but remains an extremely valuable benchmarking tool.
- f. Bertrand made an additional comment that Safe Food Canada study had similar findings from in-depth research conducted with 20 businesses. (Information regarding http://www.foodincanada. com/food-in-canada/safe-food-canada-releasesfirst-study-133529/)
- g. Presentation will be sent out to PDG members following the meeting, but can also be accessed at: https://www.campdenbri.co.uk/training/globalfoodsafetytrainingsurvey2016.pdf
- Laura Nelson Closing the gaps in food safety training, results from the global food safety training survey. Update on the work of Alchemy in building on the Campden BRI survey.
  - a. Completion of the survey has been useful for benchmarking to improve training. Perceived benefits identified in the survey indicate the commitment of the industry in relation to training and education of the workforce, as research findings indicate that the food industry believe that training will benefit the company and the industry.
  - b. Research established that lots of training commitments exist, including; GMP, personal hygiene, food safety culture, traceability and recalls, internal audit training. It was suggested that it is important to distinguish between the training of employees and supervisors.
  - c. Gaps identified 62% of respondents reported that despite training, some staff will still not follow the food safety programme. Emphasis placed on "learning doesn't translate to doing." Eighty-seven percent of respondents reported a lack of formal skills/job training for new and existing employees to be a challenge in relation to food safety training.
  - d. Contributors to lack of training included:
    - i. Training is too complex.
    - ii. Not engaging, not targeted.
    - Delivery doesn't enable retaining of information.
    - iv. Training is not reinforced consistently. Supervisors struggle with driving food safety, there is a need for businesses to engage with coaching and mentoring, which results in a 'team like' food safety culture emerging to drive forward business critical behaviors.

- v. Training programs need to change to accommodate preferences for learning.
- vi. Management drives food safety training, frontline staff need food safety training to ensure compliance and improve food safety culture.
- vii. Training staff to identify potential issues on-site was discussed to be of benefit to businesses.
- viii. Training for job task is not provided due to lack of time.
- e. Temporary workers training requirements remains a problem area.
- f. Research has identified the need for metrics to define better training. Leading indicators included product quality; however is very different to observing current employee behavior.
- g. For food safety awareness, the 'forgetting curve' was introduced to the PDG members. It is suggested that 90% of knowledge is lost in a week following employee training.
- Training problems with staff retention was discussed, and the need for innovative ways to enable operators to obtain training was suggested.
- Suggestions for the implementation of training improvement included:
  - i. Simplify training.
  - ii. Ensure training is engaging.
  - iii. Provide supervisory training.
  - Align training topics to key business outcomes, targeted training according to business needs.
  - v. Deploy coaching/mentoring.
  - vi. Create and analyse training metrics.
- j. Global Food Safety Training Survey White paper available at: http://www.alchemysystems.com/food-production/resources/ research/.
- Lone Jespersen Give the food safety learner a chance. Safe Food Canada update. Update on Canadian Education Competency Framework and Training Quality Standard.
  - a. Safe Food Canada looking at competencies and IFPTI. Discussed that the Campden BRI data is needed by the industry to give insight regarding training and to enable progress, particularly as the data do not show an improvement.
  - b. Need to explore the methods of evaluating training and identify a need for a training quality standard, to assess if training has been designed to a certain standard, is the delivery method the best for the target audience, and is the method of assessing impact working. Need for a publicly available standard. Results in the ability to purchase training package developed to a certain standard.
  - Discussed the importance of competency based learning and the potential use of Micro learning (training/education over less than four minutes).

- d. In response to questions from the floor regarding design of materials, Lone discussed the critical importance of structural design for optimal learning and the need to teach trainers how to educate effectively.
- e. Following a question from the floor regarding what has changed? Lone responded that the Safe Food Canada white paper last year had identified the need for the Food Safety Training Standard and there has been an increased interest including from PDG member. Lone welcomed the involvement of the food safety education PDG member and also welcomed the opportunity for students to be involved in the process.
- Shelley Feist Update on consumer education: Consumer Food Safety Education Conference and consumer outreach efforts.
  - Partnership for Food Safety Education is a collaboration of 26 organizations in the USA. The next consumer food safety conference is to be held on January 25, 2017 in Washington, D.C. The conference will focus on behavior change. Shelley discussed that there is currently a hunger for how to change consumer behaviour. Kathy Means and Frank Yiannas are chairs for the conference. Lou Atkins will be the key note speaker. Breakout themes include food safety perceptions and physical design to impact on behavior. Author of 'Power of Habit' Charles Duhiaa will close the conference. Shellev discussed how learning from consumer food safety behavior can be of benefit for the industry to improve behaviour. Registration for the conference opens in September.
  - D. Question regarding the need for earlier FS training. Response: GMA education foundation

     hands on programme middle school program for FS education in 15 states. Youth education likely to be discussed tomorrow in panel. Reaching millennialist beyond PowerPoint.
  - c. "The Story of Your Dinner" will launch November 1, for which the partnership for Food Safety Education is partnering with sponsors Cargill, the Frozen Food Foundation, Nestlé USA, and Publix Super Markets. The campaign, focusing on the Southeastern U.S. primarily Alabama, Florida, Georgia, Mississippi, North Carolina, South Carolina, and Tennessee, aims to improve consumer food safety practices in the home for Thanksgiving. Shelley welcomed food safety education PDG members to participate in the webinar in the run up to the campaign.

**Old Business**: Minutes from 2015 meeting were adopted without changes.

**New Business:** Outgoing Chair Kali Kniel thanked the PDG for their efforts over the last two years and shared her enthusiasm for the work of the PDG. She welcomed Sherri McGarry as incoming Chair and announced the election of Humberto Maldonado from Driscolls as new Vice Chair.

Historically, the FVSQ PDG provides a series of updates to the members, which are outlined below. *Regulatory Update:* The regulatory update was provided by Samir Assar (FDA CFSAN). The Produce Safety Rule was finalized and published. FDA continues to listen to stakeholders and consider new information as it comes in. FDA's focus has moved to an implementation strategy with emphasis on providing education, training and technical guidance to industry and working with NASDA on states' role. Draft guidance for sprouts is anticipated before the first compliance date

in January 2017. Broader draft guidance for the rule being worked on and trying to accelerate issuing draft guidance for water aspects soon. FDA is working with NASDA for future inspectional strategy and in many other areas. If the states have the resources they will handle the routine inspections and any remaining would be covered by FDA. NASDA is planning on on-farm voluntary readiness reviews and piloting in 2017. The PSA curriculum has been finalized and will begin in September 2016. FDA has provided funds for regional and national coordination centers with USDA to assess regional needs and provide specialized training for small growers and processors. Awards for grants to institutions to provide training for certain stakeholders, such as tribal communities and for sustainable farming, will be announced shortly. Produce safety network continues to build and there are many career opportunities with FDA. FDA is committed to staying connected to produce community and taking a measured approach to implementation.

Produce Safety Alliance Updates: Betsy Bihn provided the update on the PSA (http://producesafetyalliance.cornell.edu/). PSA training will initiate with a focus on Train-the-Trainer sessions (two-day course) in September 2016; first priority given to those participants registered for the previously cancelled sessions, second priority to the four regional centers; and third priority to the Northern Region and those crucial to help build more collaborations. PSA has hired several staff to support effort across the nation.

Outbreak Update: The outbreak update was given by Cerise Robinson (FDA CORE). It included a summary of pathogen and foods involved in multistate outbreaks that FDA was involved. Discussions included information on source of the food, whether domestic or imported. She highlighted a few outbreaks and high level lessons from the investigations and shared continued trends in seeing sprout outbreaks, consecutive Cyclospora outbreaks, and a few novel foods involved in other outbreaks. Cerise provided CORE's website: www.fda.gov/Food/recallsoutbreaksemergencies/outbreaks.

## Other Topics:

Suresh Pillai, USDA APHIS, provided an update and presentation to the PDG on use of irradiation on imported produce. Slide set described the technology, benefits, and why this is an area of need and potential growth.

PDG members expressed continued interest in webinars. Sherri McGarry shared that there's a webinar on sprouted seed in development.

PDG members brainstormed topics for symposia/roundtable and tried a new approach to help connect PDG members during the PDG meeting by breaking out into groups by topic areas. Sherri McGarry requested feedback on this approach after our meeting; plan is to have conference calls following IAFP meeting and before deadline to submit symposia/roundtable ideas in October.

Bobby Krishna opened the meeting welcoming the PDG members and new attendees. He reminded the participants of the purpose of the meeting and presented the proposed agenda that was accepted with no additions.

On behalf of the Board, Tim Jackson welcomed the attendees. He noted the record high attendance to this year's IAFP Annual Meeting and the growing IAFP membership. Tim also reminded attendees of the four international IAFP meetings coming up in October (Penang, Malaysia), November (Shanghai, China; Cancun, Mexico) and March (Brussels, Belgium).

**Old Business:** The minutes of the 2015 PDG Meeting were adopted as written (Bassam Annous proposed; seconded by Roger Cook).

#### **New Business:**

Success rate of last year's symposia submissions.

The Chair noted that out of the eight symposium sessions suggested by the group as well as supported by the group, six were submitted and of these, three could be found on the final program:

- S12: Harmonizing Hygiene and Sanitation Specifications for Improved Public health and Better International Trade.
- RT2: The Global Food Safety Kaledioscope.
- Review of New Risk Factor Studies and Applications to Restaurants Inspections in the U.S. and Europe.

Arie Havelaar noted that a fourth session could be counted, as the PDG also supported it:

 Session S75: The Global Burden of Foodborne Disease.

**Updates from International Organizations.** Sarah Cahill (FAO), also on behalf of Peter ben Embarak (WHO), asked the Chair to inform the meeting as follows:

Apologies for FAO not making it to the PDG meeting. However, please note that Dr. Renata Clarke, who leads the FAO food safety work, will be giving the John Silliker Lecture on Wednesday at 4:00

- p.m. (Improving Food Safety Globally: Developing and Applying Science for the Common Good) and that Mary Kenny, Food Safety and Quality Officer, contributes to S67 (Integrating Food Safety in Food Security). Here are some highlights of the work of FAO and international partners.
- Whole genome sequencing (WGS). FAO has been active on WGS in the last year, in particular to address the challenges faced by developing countries. FAO in collaboration with WHO published a Technical Paper (Applications of Whole Genome Sequencing in food safety management) and convened a meeting in Rome (May 2016) in conjunction with the 9th Global Microbial Identifier (GMI). The report of this meeting will also be available online shortly.
- Outcomes of 39th session of the Codex Alimentarius Commission (CAC). CAC report. Adoption of guidance on the control of Salmonella in beef and pork, guidance for the control of parasites in foods and additional texts relating to the establishment of microbiological criteria in foods. The scientific advice report will be published next week by FAO/ WHO. The CAC established a new task force on Antimicrobial Resistance (AMR) to revise its existing standards and consider the development of new ones relevant to the management of AMR in the food chain. This work will need to be supported by scientific advice and FAO and WHO, will be issuing calls for data and experts to support this work early next year. New work is underway to look at STEC in foods and provide Codex with the scientific basis it needs to undertake risk management work on this topic. The starting point here is the Global Burden of Foodborne Disease work that was led by WHO (report released last December).
- FAO continues to implement its work on food safety capacity development and Emergency Prevention and Response, with a strong emphasis on the interaction between these three areas. Some recent publications which may be of interest include:
  - The publication of a manual on how to undertake risk-based imported food control
  - The publication of a handbook on risk communication
  - An overview of early warning and rapid alert systems relevant to food safety
  - A handbook on food safety emergency response
- Training and workshops continue around the world on risk analysis, microbiological criteria, emergency preparedness, total diet studies and exposure assessment, to name but a few, as part of the worldwide efforts of FAO and /WHO to raise the level of food safety globally.

International Commission on Microbiological Specifications for Foods (ICMSF). Leon Gorris updated on ICMSF activities, noting that ICMSF is finalizing the revision of ICMSF book 7 by end 2016. This extensive revision represents the latest thinking on risk management metrics and useful testing in managing food safety. It provides in-depth details of the statistics underpinning sampling plans, microbiological criteria and process control and includes six hazard-commodity combination examples to bring the application of the above to live.

**Global Food Safety Initiative (GFSI).** Leslie Bourquin provided a brief update on the GFSI Global markets program.

## Regional Updates:

- Leon Gorris gave an update on Europe, focusing on food safety resources (e.g., risk assessments, opinions, rapid alerts and data on burden of chemicals and zoonosis) available from the various competent authorities (European commission, European Food Safety Agency, European Center for Disease Control and Prevention).
- Roger Cook (New Zealand) noted that a new law had been implemented on March 1 (transitional period until November (1) on requirements for manufacture and sale of raw drinking milk. The new law is a good balance of risk assessment and risk management but has still received unfavorable responses from some sellers, especially around attribution of illness to the consumption of raw drinking milk. The law, in particular its effect on foodborne illness, will be reviewed in 2018.
- Deon Mahoney (Australia) noted that raw cow milk is not allowed, despite New Zealand and Australia generally sharing approaches to risk management through FSANZ. He noted that the revised Food Standards Code came into effect on March 1, 2016. including requirements on microbiological criteria, shared between Australia and New Zealand. The microbiological criteria for foods in the Code are being reviewed with a focus on retaining food safety criteria in the Code, and moving process hygiene criteria into a separate Compendium. Changes in requirements for country of origin labelling have come into effect, resulting in ongoing discussion associated with appropriate labelling, given how foods are often produced using ingredients and (for instance) starter cultures originating from across the globe. Dairy Food Safety Victoria has recently updated its website (www.dairysafe.vic.gov.au) providing enhanced information to manufacturers, producers, and consumers.
- Bobby Krishna provided an update on the recent developments and initiatives in the Middle Eastern region. He also gave a brief introduction to the new food inspection system in Dubai.

#### Suggestions for Symposia at IAFP 2017:

Ideas for the Annual Meeting of IAFP in 2017 need to be submitted by October 4, 2016. The following topics were suggested to be developed:

- Session of online Food Safety Education tools available to grow food safety professionals at the global level (suggested by Leon Gorris; support to be sought from Education PDG).
- Session on making key food safety information available to consumers/workers effectively independent of language (suggested by Lisa Lucore. Leon to raise with Education PDG).
  - Session on international connection to FSMA, including progress in capability building and resourcing foreign suppliers (suggested by Pablo Alvarez; David Baker supporting).
  - Session to share awareness about and learnings of using online tools for auditing food safety operations, which could include

- auditing preventitive control measures (suggested by Bobby Krishna; supported by Karim-Franck Khinouche).
- Roundtable to international STEC regulation development, possibly with focus on beef industry (suggested by Roger Cook; supported by Patrice Arbault).
- Session on international Listeria regulations and recent developments in risk assessment, risk management and risk communication (suggested by Tim Jackson; supported by Leon Gorris).
- Session on getting ahead of the next lowlevel allergen contamination of agricultural food ingredients by getting better at understanding farmer practices (suggested by Lisa Lucore).

## **Low Water Activity Foods PDG**

- Melinda Hayman spoke on the recent Listeria monocytogenes contamination in low-moisture foods, sunflower seeds and some of the questions surrounding industry challenges and regulatory posture. Key points:
  - Infectious dose still not known.
  - Do you need growth to cause?
  - What is the significance of sporadic levels of Lm in frozen and dry foods?
  - Lm regulatory and policy developments, particularly around positive environmental findings on food contact surfaces. Information is expected from the Alliance to prevent listeriosis and FDA's food advisory.
  - GMA is about to begin research of Lm in low moisture foods, looking for ideas and also whole-genome sequencing.
- Sofia Santillana-Farakos presented a review of FAO's 2014 work on pathogens in low moisture food seeds, nuts, flour, herbs and tea). Key points:
  - Top three pathogens being B. cereus (highest prevalence), Salmonella and E. coli (lowest prevalence).
  - Route of contamination.
  - More data needed on concentration levels.
  - High relative variability in prevalence.

This presentation generated a lot questions and discussions around the issue and the challenge in making a determination on prevalence prior to designing inactivation studies.

Chair Marcel Zwietering, taking over from Yuhuan Chen, welcomed attendees, followed by self-introductions for all PDG members and visitors. Marcel reviewed the meeting agenda.

Comments from Executive Board: Mickey Parish indicated that this PDG is very active, both in symposia as well as in webinars. Also the whole IAFP community is doing well. This year, we are averaging around 4,100 IAFP members, 3,300–3,400 are expected at the end of the meeting, with 175 exhibitors. Both the number of participants and exhibitors have increased compared to last year. He also mentioned that future symposium presentations are strictly limited to 30-minute presentations. He requested to continue submit proposals (deadline of October 4th, 2016). Furthermore, he requested to nominate eligible candidates for IAFP awards. This year marks the first time to register participants through scanning of badges. New members to the PDG are automatically enrolled through the scanning of the badges. [Editor's Note: new members are not automatically enrolled. Members should join a PDG through the IAFP Web site by updating the Professional Info tab in their Member profile.]

Minutes from the 2015 meeting were tabled for comments or edits. There were no edits. Motion to adopt the minutes by Yuhuan Chen, seconded by Leon Gorris and Thomas Bell. Minutes adopted.

#### New Business:

- Thank you to past Chair and election of new Vice Chair: Marcel Zwietering and the PDG members thanked past chair Yuhuan Chen for her outstanding leadership and for the many accomplishments of the PDG achieved under her leadership, not only illustrated in the symposia and webinars but also the networking and collaborations among PDG members, and collaborations with other PDGs. To show the impacts from Yuhuan's leadership, Marcel mentioned "Yuhuan is a most friendly person, always smiling and socializing, but at the same time a perfect organizer and networker. It can only get worse; I should not have taken the job!" Marcel also quoted a message from Alejandro Amezquita (Past Chair): "It's been a pleasure to have served in the leadership of the MMRA PDG. As a strong advocate of predictive modelling and risk-based approaches applied to food safety, I feel proud to see how this PDG continues to grow from strength to strength, with excellent outputs, and keeping a global community of members and other interested professionals engaged. This would not have been possible without the commitment of the energetic colleagues who worked with me in the leadership for the past couple of years. Therefore, I want to thank Yuhuan for her outstanding role as PDG Chair in 2015-2016, and I wish Marcel and Bala success for the next year. The PDG is in excellent hands. Thanks."
- Yuhuan thanked everyone for supporting her and also mentioned the following: "Thank you so much, MMRA. It's great to chair the Committee. I want to thank everyone for your support. It was terrific to work with Alejandro Amezquita, immediate Past Chair, and with Marcel in the PDG leadership. I have very much enjoyed working with Alejandro and Marcel, and with all of you. As a forum for MMRA, one thing that stood out is the quality of the symposia, workshops and webinars the Committee helps organizing - more than 10 proposals every year and acceptance rate is very high - 80%. The Committee is amazing. Now that the torch is passed to Marcel and we welcome a new Vice Chair, I think Alejandro put it very well - the Committee is in good hands for much more success in the years ahead. Thank you so much!"
- Bala Kottapalli was introduced as a new Vice Chair to the PDG group. Marcel explained the selection process for new Vice Chair. This included multiple nominations from PDG members and elections through a voting process. Marcel indicated that this type of selection process will be adopted for future selection of Vice Chair(s); hence nominations are welcome. Nominations are welcome from different regions and affiliations (industry, government, academia etc.).

**Guest Speaker: Matthias Filter** is senior research scientist in the unit "Food Technologies, Supply Chains and Food Defense" at the Federal Institute for Risk Assessment (BfR), Germany.

Matthias coordinated several software development and modeling activities within the BfR. In several national and international research projects, Matthias promoted the idea of standardized information exchange as the basis for harmonization, transparency and knowledge generation.

Mathias presented the following topic, "Update from RA Software/Data Exchange Workgroup – Available Resources and Current Developments." The purpose of this software

was to support risk assessors with mathematical models and model-based software tools. He described a four-step process (Step 1: Model Exchange Formats, Step 2: Rules for Model Annotation, Step 3: Community Contributions and Step 4: Food Safety Knowledge Bases) that is required to generate food safety knowledge bases. He provided an overview about the current progress on the development of software and also harmonization to facilitate exchange of mathematical models. He concluded his presentation by indicating that the vision of "sharing models and modules" is achievable and more joint efforts are required in this area to fulfill the vision.

Following the presentation, there was some discussion on the following points:

- When integrating different models validation of the individual models as well as the integrated model is necessary, how would the software achieve this?
  - QC of models should be done before uploading to the repository. There should be an editorial board reviewing the QC of the uploaded models.
- · Is it a server-based software?
  - It is a desktop software.
- · How do you address propagation of errors?
  - While this item was not on the priority list of the development of software, one suggestion to address the propagation of errors is to have an idea of uncertainty/variability of the models as well as sufficient documentation across different models which will help risk assessors to make knowledge based food safety decisions.

**Update from the ICPMF Committee:** Marcel Zwietering (as being the Past Chair of the International Committee on Predictive Microbiology of Food) gave an update. The next conference, ICPMF10, will be in Cordoba, Spain on September 26–29, 2017. Since 2015 ICPMF became a subcommittee of the ICFMH (International Committee on Food Microbiology and Hygiene of the IUMS). Also, good relationships and cooperation with the IAFP are continued.

#### Symposia/Workshops/Roundtables - Overview 2016

A total of 11 proposals were submitted by the members of PDG which the MMRA PDG sponsored or co-sponsored. Nine out of 11 were accepted. This allows us to continue to submit good quality proposals in the area of MMRA and also continue to collaborate with other PDGs. Especially making good links is very well appreciated, and very much feasible in our group, symbiosis between legal, industry and academia, on the one hand, and on the other hand between mathematics, statistics, informatics, microbiology, and product specific knowledge.

#### **New Business:**

- Bassam Annous, Chair, started the meeting by welcoming everyone and introduced Dr. Walid Alali, incoming Vice Chair. Bassam thanked Dr. Divya Jaroni, outgoing Chair, for her services to the PDG, and Dr. Alali for volunteering to serve the PDG. This was followed by welcoming the attendees and introducing themselves. Bassam asked those attendees who have not registered yet to write down their names on the sign-up sheet. Bassam asked attendees to join any PDGs online and/or send an E-mail to the Association with request to join or be removed from PGD mailing list.
- Bassam mentioned that the minutes from the 2015 meeting were E-mailed to all members and were also available online at IAFP Web site. He asked for a motion and second to approve them at this PDG meeting and were approved.
- Dr. Rodney Moxley from University of Nebraska presented "Pre-harvest Research Progress through STEC CAP" (25 minutes presentation). A five-minute question and answer period was followed.
- Kali Kniel, IAFP Executive Board Member, welcomed all and talked about IAFP and PDGs. She mentioned that IAFP is on a successful track and more attendees in this year's meeting compared with last year. About 3,400 attendee and more than 170 exhibitors. Kali encouraged PDG attendee to promote IAFP membership through friends and colleagues, nationally and internationally. Regarding JFP, she mentioned that changes to the journal platform are coming. Kali encouraged attendee to consider IAFP journals (JFP and FPT) when submitting their publications. She also talked about the decision of the Program Committee to limit the 2017 symposium talks to 30 minutes. Furthermore, a recommendation was made to promote the use of webinars.

- Kali reminded the group of award nominations.
   The awards' criteria and guidelines are available on IAFP websites.
- Bassam thanked Kali for IAFP support and the information provided. He then mentioned that our PDG had seven symposia accepted and presented during last year's meeting (2015), while this year 10 symposia, including roundtables, were accepted. Bassam also made the group aware that non-members of PDGs are allowed to submit proposal for symposia. Bassam encouraged members to collaborate on symposia with members of other PDGs. Bassam mentioned that webinars and presentation at the PDG annual meeting would be another venue for presentations of important subject matter important to the members. Bassam stressed the importance of having three and six speakers per half and full symposium, respectively. This format was approved by the Program Committee and will be enforced.
- Bassam then opened the discussion on symposia topics. He mentioned that the deadline for submitting the proposals for next year's meeting is October 4, 2016. Bassam started the discussion by talking about a number of recommendations that attendees can think of while formulating symposia topics and later proposals. These areas were:

  - Development of booklets or pamphlets.
  - Regular web meetings.
  - Communicating regularly via E-mail or teleconference.

This was followed by PDG members proposing topics and discussing them.

- Global needs assessment by Paula Cray. The focus is on assessment of needs in developing countries to improve capacity building in collaboration with WHO-FAO. It can be a half symposium with three speakers.
- Water quality and fresh produce safety by Diane Ducharme. The focus is on farm water quality and availability challenges in relation to produce safety nationally and internationally. It can be a half symposium with three speakers.
- FSMA: The devil in the details by Michelle Smith.
   The goal is to provide details on FSMA on produce and how to get them out to stakeholders. This can be a roundtable.
- Updates on food safety from US Regional Centers by Angela Shaw. The goal is to provide updates on the food safety research and outreach by regional centers in the U.S. This can be a roundtable.
- Complementary forces of mitigation in food safety of global issues: Detection and mitigation by Paula Cray and Megan Jacob. The aim is to better understand the dynamics of bacteria and their

- genetic material transfer in addition mitigation strategies. It can be a full symposium with six speakers in two sessions.
- Status of intervention methods in developing countries by Modesto Olanya. The aim is to better understand the intervention methods that work in developing nations in relation to needs assessment. It can be a half symposium with three speakers.
- Soil issues and produce safety. The goal is to understand soil amendments in relation to produce safety. It can be a half symposium with three speakers.
- Fresh produce safety and natural disasters by Wenqing Xu. The goal is to discuss the safety of produce (microbial quality, guidance to stakeholders, and quick response) after events such as flooding. It can be a half-symposium with three speakers.
- Pre-harvest AMR and antibiotic use by John Heller.
  The aim is to discuss pre-harvest AMR issues and
  where antibiotic are used in the production chain in
  produce and other products. It can take a roundtable format.1
- One of the members, Ruth Eden, mentioned that she started a new Web site (http://ask-bioexpert.com/) on food safety to exchange/share information and provide expert opinions on different topics including methodology previously used by other researchers. The website also provides a forum for Q&A. Whomever is interested needs to become a member of the website before participating. She would like people to give her feedback after they visit the website.
