Ohio Association for Food Protection: Winter Meeting Held Despite Low Temps Reported by Connie Freese, Delegate



The Ohio Association for Food Protection (OAFP) held its Winter Food Safety Meeting on one of the coldest days of winter! Attendees braved – 15° windchills and piles of snow on the

ground to attend the meeting held on January 22, 2025 at Franklin County Public Health in Columbus.



The Affiliate utilized Dr. Kathy Glass, Distinguished Scientist and Associate Director at the Food Research Institute, University of Wisconsin – Madison, from the IAFP Executive Board Speaker Program. Along with a presentation about IAFP Membership, Dr. Glass presented "Intervention Strategies to Control *Listeria* in RTE Foods," and "Control

of Sporeforming Bacteria During Extended Cooling and Refrigerated Storage." Both presentations were extremely informative and of great interest to the attendees. We appreciate the effort she took to tailor the presentations to food safety issues that Ohio has been facing during the last couple of years.



Karin Kasper, MPH, REHS, and Mike Hills, MS, REHS, both from Franklin County Public Health, presented on "Food Safety Manuals." They shared how there was a need to provide food safety manuals in non-English languages within Franklin County, Ohio. The county health district secured a grant and determined which languages were most used within the community, developed manuals, and distributed them to its licensed operations. The manuals reflect the requirements of Ohio's Food Safety Code and can be found on the district's website.



Dr. Sanja Ilic, Associate Professor and Food Safety State Specialist, The Ohio State University, provided information on her research utilizing data from Scotland in her presentation, "Who is at Risk and How We Communicate to the Vulnerable Consumers." Of primary interest

were which statements should be used to communicate to consumers regarding those risks associated with eating certain foods, and would consumers ignore the statement because they did not think it pertained to them.



Tom Jalamov, Compliance Agent, Investigative Services, Ohio Department of Commerce Liquor Control, presented on the liquor laws and rules as they pertain to food operations in Ohio. The focus was on the interaction and cooperation needed between the local health departments, state health

and agriculture departments, and liquor control regarding food safety in operations.



The day's final speaker was Jason Ahrens, REHS, Ohio Department of Agriculture, who spoke on "Survey of Transportation Accidents Involving Food and Drugs." Attendees learned that each accident involving cargo trains or semi-trucks with

food are inspected to verify the food is still safe for consumption. If not, it is embargoed, and the product is destroyed.

March 3-4, 2025, bringing together 64 professionals and student members who work in food safety across regulatory, manufacturing, retail, academia, and allied industries.



The event opened with a welcome from Faith Critzer, GAFP Vice President, followed by a networking session led by Rawane Raad (left), Social Media Chair, where groups competed against each other by answering food safety trivia.

Everyone had a great time, and it proved a good way to foster connections among attendees.



Summer Williams, Deputy Director of Food Safety, Georgia Department of Agriculture, provided an update on regulatory development affecting the food industry. Attendees learned what the depart-

ment has been working on, from responding to bird flu to protecting the safety of foods sold at major sporting events. The department has been very productive, and we're all better for it.



A discussion followed on X-ray solutions for food safety, led by Joe Aleszczyk, Flexxray, highlighting how

advanced imaging technology can enhance quality control and physical contaminant detection.

Following a networking lunch, Charles Otto III, GAFP Past President, led the Affiliate Business Meeting, where members of the Executive Committee addressed key updates and initiatives. Attendees were also introduced to the candidates for the 2025 -2026 Chair Elect position and for the IAFP Affiliate Delegate position.



Afternoon sessions turned to sustainability, with Gaby Saavedra, Georgia Tech's Manufacturing

Extension Partnership (GaMEP), presenting on sustainable practices in food manufacturing and

the ways this sector can drive sustainability initiatives for long-term progress.



The final presentation from Dr. Valentina Trinetta, Professor, Kansas State University, explored decision-making tools for optimizing cleaning and sanitation practices, focusing on controlling *Listeria monocytogenes* biofilms in food processing environments.

Australian Association for Food Protection: Joint Conference Draws 120+ Attendees

The Australian Food Microbiology Conference was held March 5–6, 2025 at Olympic Park, Sydney, Australia. The event was co-organized by the Australian Institute for Food Science and Technology (AIFST), the Australian Association for Food Protection (AAFP), and the Australian Society for Microbiology (ASM).



Keynote speakers and topics included:

Dr. Manan Sharma, USDA and IAFP Vice President, presenting virtually on "The Intersection of Produce Safety and Sustainability;" and

Dan Li, Assistant Professor, National University of Singapore, discussing "Indoor≠Safe: Microbial Safety of Indoor Hydroponic Farming Systems;" and "Measurement of Human Norovirus Infectivity: Why and How."

Several Australian-based presenters and topics included:

Dr. Julian Cox, Associate Professor, University of South Wales, "Water and Energy Recovery in Poultry Processing;"

Dr. Sukhvinder Pal (SP) Singh, NSW Department of Primary Industries, "Water Quality Challenges for the Production and Processing of Safe Leafy Vegetables;"



The theme for the 2025 Food Microbiology Conference was "Bugs in the Balance: A World of Diversity." The event was presented as an in-person meeting offering a two-day, content rich program including international keynote and local speakers from academia, government, and industry. Deon Mahoney, Adjunct Professor, AIFST and the University of Queensland, "Sheep, Rainfall, and Lettuce: What Could Go Wrong?;"

Martyn Kirk, Professor, Australian National University, "A Systems Approach to Improving Investigation of Foodborne Disease Outbreaks;"

Dr. Sameera Sirisena, University of Melbourne, "Mapping the Taste of Yeast – Role of Yeast Proteins, Peptides and Amino Acids;"

Anne McIntosh, NSW Food Authority, "*Listeria* – Overview of Recent Investigations;"

Mark Turner, Professor, University of Queensland, "Maturation of Vegan Cheeses;" and

Sajid Akbar Madari Valathodi, Novonesis, "Why Bioprotection Makes Sense."

The program's structure allowed significant opportunities for networking and collaborating. The goal was to deliver a professionally rewarding experience, which provided a platform to make professional contacts and takeaways that elevated knowledge of current issues of food microbiology. The meeting attracted more than 120 attendees from across the entire food industry, as well as food regulators, academics, researchers, and government officials. A dedicated "Emerging Researchers" session included three talks from Ph.D. students and early career researchers, selected from an open abstract call.

British Columbia Food Protection Association: Annual General Meeting Held Virtually

The British Columbia Food Protection Association (BCFPA) held its Annual General Meeting virtually on March 11,

2025, through the Zoom platform. Nineteen members registered to hear from the Affiliate Board Members who delivered the 2024 AGM Report and covered other business.



Manpreet Singh, Professor and Head, Department of Food Science and Technology, University of Georgia, Athens, and IAFP President-Elect, was invited under IAFP's Executive Board Speaker Program to talk on managing risks in poultry processing. He emphasized on pre- and post-harvest food safety procedures, and discussed potential new changes in regulations. A Q&A period followed, with BCFPA members asking many engaging questions. The evening continued with AGM business, including a summary of events hosted in 2024, and highlights of finances, membership, and the Student PDG. The meeting closed with the nominations for the 2025 Executive Board and an informal chat with many members who were willing to be "on camera."

Florida Association for Food Protection: Winter Luncheon with Three Speakers Reported by Taylor O'Bannon, President



The Florida Association for Food Protection (FAFP) hosted a successful Winter Luncheon on March 13, 2025, at the Citrus Research and Education

Center in Lake Alfred. Twenty-seven attendees representing academia and private industry gathered to share, network, and engage with industry. Participants were treated to a series of informative presentations by the following speakers:

Dr. Stephanie Brown, State Specialized Agent in Food Science, speaking on "*Listeria* in Ice Cream and Soft Cheeses," highlighting critical food safety concerns and mitigation strategies;



Dr. Jason Scheffler, Professor, Animal Sciences, University of Florida, presenting "Avian Influenza and Its Impacts on Food Animal Industries," offering valuable perspectives on the current challenges and biosecurity measures affecting animal agriculture; and Debby Newslow, D.L. Newslow and Associates, discussing the "Background and Upcoming Regulatory Changes Concerning Red Dye No. 3," providing practical insights into evolving food safety standards.



Following the presentations, attendees enjoyed an educational tour of the Citrus Research and Education Center's Citrus Packinghouse and Processing area, where they had the unique opportunity to view the first evaporator used to produce concentrated orange juice – a pivotal innovation in Florida's citrus industry. Lunch was served by Lang's Taste of Florida Café, a beloved local establishment run by a longtime citrus industry family, adding a touch of local flavor and tradition to the event.

The luncheon successfully fostered learning and collaboration among food protection professionals, and we look forward to future meetings that continue to support and advance food safety within the state.

Idaho Environmental Health Association: Joint Conference Held

The Idaho Environmental Health Association (IEHA), in conjunction with the Idaho Solid Waste Association, held its Annual Joint Conference

March 18–20, 2025. The two organizations have partnered for more than 10 years to help build the relationship between public health and the state landfill operators. Approximately 30 people were in attendance over the two-and-a-half-day meeting. Topics covered included food, on-site wastewater, underground storage tanks, and pest management.

David Dyjack, NEHA Executive Director, presented on the state of environmental health and workforce. Time was also dedicated to discuss raw milk. In 2022, Idaho updated its rules regarding testing and herd numbers.

Next, a presentation from Wild Space Farms, which sells raw milk within the state, outlined its process. Finally, Idaho Central District Health discussed an outbreak related to raw milk. A panel discussion followed the three presentations to allow audience members to address all speakers.

Al is the future, and JD Wardell, Ph.D. candidate from Idaho State University, shared his "FoodBot," which uses Al. This program is designed to assist food operators in understanding the food code, and was built around the Idaho Food Code and the 2013 FDA Model Food Code, which Idaho currently uses. Included in the program was the ability to write a script for training staff.

IEHA celebrates its 70th anniversary in 2025! The original charter was drawn up in 1952. To celebrate, the association held a contest with photos submitted from environmental health specialists (EHS) throughout Idaho. In the state, these specialists are generalists and work in many different areas. Photos ranged from "icky" kitchens to questionable onsite sewage situations to animal helpers at the worksite. A game of Ladder Ball was also added to the fun!

IEHA looks forward to growing and retaining its members, seeking a wide range of experts to present at its annual conference, and continuing its partnership with the Idaho Solid Waste Association. IEHA's 2026 Annual Conference will be held March 17–19, in Boise, Idaho at the Riverside Hotel.

Indiana Environmental Health Association: 125 Attend Spring Conference Reported by Tami Barrett, Contact



The Indiana Environmental Health Association (IEHA) convened its 2025 Spring Conference on April 10 in Indianapolis. IEHA Vice President Shane Hatchett hosted the meeting that drew 125 attendees.

Under the theme, "Amplifying the Public Health Message," the conference included public health professionals, policymakers, and industry leaders coming together to discuss pressing challenges for state and local partners.



Dr. Lindsay Weaver, Indiana State Health Commissioner, opened the conference with her keynote lecture on the "State of Health in Indiana." Dr. Weaver highlighted the state's commitment to transforming its public health system through increased funding and strategic investments. She emphasized the emerging data on return-oninvestment for public health interventions, further underscoring the economic and multi-sectorial value of preventive measures.

Participants also heard from speakers about emerging infectious disease trends such as highly pathogenic avian influenza, vaccine-preventable diseases, and ways to address misinformation about public health.

The meeting included the Association's Semi-Annual Business Meeting led by President Andrew Pappas, followed by a networking luncheon for attendees.



Afternoon sessions focused on policy education and regulatory updates from key organizational partners. As in years past, the burgeoning home-based food vendor market for boutique products and mobile food establishments were popular topics. Indiana continues to experience a push-and-pull between deregulation and avoiding potential food hazards as legislators and cottage industry advocates propose legislation to allow greater scale without additional regulatory oversight.



IEHA's 2025 Spring Conference offered a space for camaraderie in the midst of the current "tumultuous" American public health system. Multiple attendees expressed concerns about federal budget cuts and the potential reduction of already-strained programs.

The IEHA Fall Conference and Semi-Annual Business Meeting will be held September 29–October 1, 2025, in Lawrenceburg, hosted by President-Elect Zak McKinley.

How It Works
