## Steve Murphy Delegate, New York State Association for Food Protection



**OCCUPATION** | Senior Extension Associate, Department of Food Science, Cornell University, Ithaca, New York, under the Milk Quality Improvement Program in Dairy Foods Extension.

**QUALIFICATIONS** | B.S. in Microbiology and M.P.S. in Food Science, both from Cornell University.

**CAREER HIGHLIGHTS** | After earning a B.S. in 1979, the 'real world' job market for general microbiologists had little to offer, so Steve returned to Cornell and accepted a position as a technician in Dr. Robert Zall's Food Science laboratory. At that time, Dr. Zall was engaged in a project funded by the NY State Dairy Farmers (checkoff funds) that investigated the use of on-farm sub-pasteurization and membrane concentration of milk. Thus, Steve's career began in dairy foods research and extension. One important perspective that Steve learned from Dr. Zall is that "there are no small jobs – everything is important!" With the continued support of the NY State Dairy Farmers, Steve moved further up the ladder at Cornell, obtaining his master's degree in Food Science and taking a position in the Dairy Foods Extension Program under Professor David Bandler, replacing another mentor, Gene Wolffe, who retired. Under Professor Bandler and the Milk Quality Improvement Program, Steve branched out further, providing NY State's dairy industry with training and consultation in basic dairy science, dairy food quality and safety.

**PORTFOLIO** | Steve has been an IAFP Member since 1988 and currently serves as Delegate for his local Affiliate, the New York State Association for Food Protection (NYSAFP). He spent three years on the IAFP Program Committee (2000–2003) and served as Affiliate Council Chair and a Member of the IAFP Executive Board (2003), which he considers a valuable and enlightening experience ("The Board and IAFP staff do a LOT of work!"). He is also a member of the Dairy Quality & Safety PDG and a past member of the Constitution & By-Laws Committee. Steve continues to be active in NYSAFP, serving on the Laboratory Committee, maintaining the Affiliate Web site and providing support for their Annual Meeting. He is also involved with the National Conference on Interstate Milk Shipment (NCIMS Laboratory and HACCP Committees) and the Dairy Practices Council.

**PERSONAL ENDEAVOURS** | Steve spends his spare time hiking, golfing, hunting, cross-country skiing and walking the Cornell campus. He also enjoys traveling to many places, with a cross-country companionship providing the inspiration to do so. ## Alabama Association for Food Protection

## The Makings of a Strong Affiliate

Alabama has an early history of promoting food safety. Sometime around 1922, the Alabama State Board of Health and the U.S. Public Health Service cooperatively began a state-wide milk program based on the need for regulated sanitary conditions and the need for milk pasteurization to control milkborne diseases. Like many other IAFP Affiliates, the Alabama Association for Food Protection (AAFP) had its beginnings with the dairy industry. Initially, a large portion of the members were directly involved with the dairy industry serving as plant managers, cooperative managers, plant supervisors and/or quality control managers. Members not working in the dairy industry typically were health department sanitarians or individuals associated with Auburn University's College of Agriculture and/or the Alabama Cooperative Extension Service. The

dairy extension service representatives were mostly assigned to the Auburn University campus.

## In the Beginning

The first Affiliate meetings, then known as the Alabama Dairy Conference, were held in the early 1970s. Russell Wright, Director of the Alabama Department of Public Health's Division of Sanitation, and William "Shep" Phillips, Milk Division Director, were resolute that the conference always maintain a program that was educational and the program topics were of a timely nature to ongoing issues that would benefit the Alabama Dairy

Industry. The early meetings were held on the Auburn University campus a day prior to Auburn's homecoming football game, thus allowing the conference members an opportunity to visit and remain on campus for agriculture activities prior to the start of the game. Travel around Alabama in the early '70s could be a time-consuming task due to the lack of four-lane roads. Auburn University is the largest of Alabama's land grant institutions and many conference speakers and attendees were Auburn University faculty and graduates, especially from the Dairy Science Department.

## **Changes Help**

During the early 1980s, the demographics of the attendees started to change, with an influx coming from the non-dairy segment of the Alabama food industry. Robert Shelton, Division of Inspection Milk Specialist, planned the annual meetings and (continued from page 4)

recognized that the makeup of the attendees was changing. Therefore, it made sense that the meetings be moved from Auburn to a more centrally-located area in Alabama, such as Birmingham. The move would allow those individuals associated with non-dairy food industries and traveling from outlying areas the ability to take advantage of the newly developed interstate highway system.

Once the location moved to Birmingham, attendance consistently rose from an average of 70 to over 100. The move was a major advancement for our organization and set the path for what was to become Alabama's affiliation with IAFP.

## **Combining Forces**

In the fall of 1987, Robert Shelton and Dr. Tom McCaskey suggested that our group consider joining the International Association of Milk, Food and Environmental Sanitarians (now IAFP). The Planning Committee agreed, and an organizational meeting was held the following January for the purpose of establishing a state Affiliate of IAMFES. A constitution was adopted and officers were elected for the upcoming year. In order for a state to have an Affiliate chapter, a minimum of five members - including the President and Delegate were required to be Members of IAFP; fortunately, Alabama al-

ready had a newly-formed membership of 24. Our application was forwarded to the IAFP Board, and the Alabama Affiliate was chartered on August 3, 1988. Annual dues for the Alabama Association of Milk. Food and **Environmental Sanitarians** (AAMFES) were set at five dollars (and remain at that price today). A business meeting was held November 10, 1988, where it was agreed to have a spring and fall meeting each year. The fall meeting would be held in November jointly with the Alabama Dairy Conference. The spring meeting was held for two years, then discontinued due to marginal participation. The decision was made to put all the planning and organizational effort into one annual meeting.

To build interest in the newlyformed AAMFES Affiliate, a modest state-wide survey was conducted in the spring of 1989 to determine who might be invited to join our organization. A letter was sent from the Association to over 350 food company representatives explaining the organization and inviting them to join and participate in our annual meetings. This resulted in a significant increase in our Affiliate membership over the next ten years, and ultimately AAMFES was awarded IAFP's award for "Affiliate Membership Achievement" in 1998.

Now known as the Alabama Association for Food Protection, our Affiliate strives to provide Members and related food service industry representatives with pertinent information on current food safety issues. Speakers who have served on our annual programs are those who have gained prominence in their field of endeavor. AAFP has also taken advantage of IAFP's Executive Board Speaker Program to enhance the quality of our educational programs. Past IAFP speakers have included Dee Buskee, Robert Sanders, Jack Guzewich and Frank Yiannis. Other prominent speakers have included the Alabama Commissioner of Agriculture and Industries; the Dean of the College of Agriculture, Auburn University; State Health Officers of the Alabama Department of Public Health; and several speakers over the years from the FDA. Program topics which addressed current public health issues contributed toward AAFP receiving the IAFP award for "Best Affiliate Overall Meeting" in 2011.

Meeting attendees include individuals from various segments of the food industry; regulatory officials from county, state and federal levels; representatives of (continued from page 5)

companies which provide services to the dairy and food industry; and individuals from Alabama's universities. AAFP actively promotes food safety training for allied agencies and industries. We also affiliate with and support organizations to help locate meeting facilities for training personnel; help with registration; and manage monetary funds for state, regional and national meetings and conferences, including the National FDA Dairy and Food Training programs, the Alabama Department of Agriculture and Industries training, and the Alabama Department of Public Health training sessions.

AAFP also supports the Alabama Food Safety Task Force and the Alabama Food Program Supervisors Workshop by holding our annual fall meetings in conjunction with their annual meetings. These cooperative educational training efforts help AAFP to meet its Mission Statement: "To provide food safety professionals with a forum to exchange information on protecting the food supply."

## **Supporting Our Future**

In 2008, AAFP established a Scholarship Program to promote students' interests in careers in the food sciences and food safety disciplines. The Scholarship application is open to all students pursuing a degree in a food or a food-related science program at

an Alabama university. At AAFP's 2009 Annual Meeting, the student scholarship was officially named the "AAFP G.M. Gallaspy Food Safety Scholarship" in honor of G.M. Gallaspy for his many years of service to the Alabama Affiliate. The first four scholarship recipients earned their degrees in a food science field and have taken jobs within the food industry. Two of the scholarship recipients have plans to earn advanced college degrees.

AAFP has a sound foundation supported by the hard work of its founders and early members. As AAFP has built on this foundation, new ideas have emerged and annual meetings have improved and attracted new members. In addition, outreach and affiliation with other food-related organizations and agencies involved in food safety have broadened our participation in community, county, state and regional efforts, allowing us to inform and communicate about food safety to our members. Like the early Alabama food safety supporters of the 1920s who helped foster good sanitary practices and pasteurization of milk to control milkborne diseases, AAFP strives to build on that early foundation to further advance food safety by providing a forum for educating and training our members.

We look forward to the continued cooperative affiliation with IAFP and to a successful future of serving the professional needs of our members.

### Missouri Milk, Food and Environmental Health Association: Annual Conference Draws 200

The Annual Educational Conference for the Missouri Milk, Food and Environmental Health Association



(MMFEHA) was an enlightening and informative meeting for the approximately 200 environmental health specialists, dairy regulators and state

personnel who attended on April 11– 13. Held at the Stoney Creek Inn in Columbia, the conference opened with welcome messages from various environmental affiliations from around the U.S. **Walt Coleman**, owner of Coleman Dairy and an NFL Official, delivered a motivational power point presentation. **Don Schaffner**, IAFP Executive Secretary, gave an overview of IAFP and spoke on "Understanding

and Managing Food Safety Risks."

On Thursday, attendees were able to choose between breakout sessions that included topics on Morgellons disease; the Joplin tornado disaster response; Asian Food Task Force; Fly Control in Dairy; and Recent Emergence of Novel Influenza Viruses. Thursday evening's Awards Banquet included the presentation of the Ecolab Sanitarian Award, the Edmonson Award and the Harold Bengsch Scholarship.

### Ontario Food Protection Association: Spring Meeting Another Success!

President Marc Charlton kicked off the 2012 Spring Meeting of the Ontario Food Protection Association (OFPA) at the

proved excellent with 175 registrants and all trade show display tables filled.

The day's first speaker was **Gloria Swick-Brown**, Ohio Department of Health retiree and IAFP Affiliate Council Chair, whose talk, "How to Be a Sanitarian: The Things You Didn't Learn in College," was both informative and entertaining. Besides lobbing a rubber chicken and rubber frog into the audience, Gloria relayed many personal experiences encountered over her years as a public health inspector. Her ultimate message : "Stay current, attend conferences and continue to learn because every day has new discoveries."

Larry Mendes, Sanitation Programs Manager for Maple Leaf Consumer Foods, continued the morning session with "Moving Your Sanitation Program from Good to Great." He explained that the components that make a sanitation program successful are the tools (i.e., hot water and quality sanitizing products), support and commitment from the top down in the organization, measurement and training.

Gino Niro, Mechanical Manager, Ausenco Engineering Canada, Inc., discussed "Sanitary and Sanitation Considerations in HVAC Design," providing background on the legislated and non-legislated requirements for HVAC in food manufacturing.

Frank Massong, Director of Regulatory and Government Affairs, Paul Valder Consulting, provided an update on "Allergens, Gluten and Sulphites...Are You Ready?" He stated that there is no guidance document yet available for the amendments to the Food and Drugs Regulations published in 2011, but provided a brief overview.

The morning session closed with four brief presentations on innovations in applied sanitation from some of OFPA's Sustaining Corporate Member community.

**Roger Johnson**, Public Health Agency of Canada, started the afternoon with his presentation, "Update on Non-O157 Shiga Toxin-producing *Escherichia coli*," stating that an ideal test would be a single screening one that would be fast, reliable and broad enough to identify a sample of specific concern while specific enough to include priority STEC and exclude low-risk STEC.

Allen Saylor, Vice President for the Center for Food Safety & Regulatory Solutions, spoke on "FSMA – Impacts to Canadian Food Companies & Export to the U.S." He explained the written performance standards including supervisor/employee training, mandatory environmental monitoring program, mandatory allergen control program and mandatory GMP program.

Tatiana Koutchma, Research Scientist, Agriculture and Agri-Food Canada, presented "Novel Technologies in Food Processing," regarding the challenges of modern food production in controlling safety, preserving food and transforming raw products into finished goods for a global market.

Julie Powell, Vice President of Technical Services & Operations, SYNAPS International Inc., concluded the meeting with "Customer Loyalty – Quality Assurance – Manufacturing: The Uneasy Alliance," focusing her presentation on the concept that "great quality perception is based on teamwork and interaction of customer care management; packaging design; marketing and sales; and production quality," emphasizing that none of these can stand alone.

#### Indiana Environmental Health Association Annual Spring Educational Conference: Varied Speakers Contribute to Success Reported by Mike Mettler, Vice President

The Annual Spring Educational Conference of the Indiana Environ-



**mental Health Association** (IEHA) was held at the Fort Harrison State Park Inn on April 25. One hundred twenty-one attendees heard

an interesting lineup of speakers and presentations on various environmental public health subjects.

**Charles Santere**, Purdue University, spoke on the maternal and child health benefits and concerns of fish consumption. **Denise Wright** from the State Health Department's Environmental Public Health Division discussed "What You Need to Know About Grease Trap and Septic Tank Additives: Graphic Content Included." **Jason Ravenscroft**, MPH with the Marion County Public Health Department in Indianapolis, pre-

sented findings of a healthy homesrelated study conducted by his agency on the connection between housing conditions and asthma severity. **Jo Anna Shimek**, Indiana University, addressed current ethical issues in environmental health. And **Jennifer House**, DVM with the State's Veterinary Epidemiologist, closed with information on preventing diseases associated with animals in public settings such as fairs, petting zoos and daycare facilities.

#### Metropolitan Association for Food Protection: Six Presentations Fill the Day

The Metropolitan Association for Food Protection (MAFP) held its 2012 Spring Seminar at Rutgers University, New Brunswick, NJ, on May 2. Over 120 attendees from government and industry gathered to hear six presentations addressing (continued from page 9)

current topics and challenges facing food safety professionals today.

Stan Cherkasky, Comprehensive Food Safety, LLC, was the keynote speaker. His entertaining and informative presentation, "The People Side of Food Safety – Building Quality Relationships," was based on a study suggesting that all people are in some way grouped into one of four personality styles based on a scale of assertiveness and responsiveness.

Michele Malavet, MSA, REHS, Foodborne Disease Surveillance Coordinator of the NJ Department of Health & Senior Services, presented "The Pathogens Associated with Raw Milk Outbreaks," regarding the symptoms and long-term consequences associated with consuming raw milk.

Alan Talarsky, Dairy Project Coordinator, NJ Department of Health & Senior Services (and MAFP Board Member), followed with "Facts About Raw Milk," addressing current laws and regulations affecting the sale of raw milk in NJ and explaining the pros and cons related to its consumption.

**Christine Knezevich**, CIH, Chemetall Inc., spoke on the FDA's defined "Big 5 Foodborne Pathogens." She provided the audience with a review of these pathogens – *Salmonella*, *E. coli*, Norovirus, Hepatitis A and Shingellosis – describing their symptoms and potential health impacts.

**Karl Mathews**, Rutgers University's School of Environmental and Biological Sciences, presented "Produce Contamination – Unlike Vegas, What Happens on the Farm Doesn't Stay on the Farm." He spoke on the importance of fresh fruits and vegetables in a healthy diet and the potential health hazards due to processing. His presentation included a fascinating case study of the Jensen Farms cantaloupe recall in 2011.

Michael Pierce, Technical Sales Director with Trece, Inc., closed with "IPM – Intelligent Pest Management," giving a comprehensive look into an ecologically responsible pest management program and the use of Pheromone Monitoring as a substitute for pesticides.

#### Florida Association for Food Protection: 140+ Attend AEC Reported by Jenny Lahnoudi, President

Gloria Swick-Brown, IAFP Affiliate Council Chair, treated attendees to a "Farm-to-Fork Safety" slide show. Drew Deberry, Deputy Commissioner of the Texas Department of Agriculture, concluded with a realistic understanding of what to expect in Texas agriculture in a political year environment.
