

Each year, as stipulated by the IAFP Constitution and Bylaws, Affiliates are required to submit an annual report to David Tharp, Executive Director of IAFP. It is the responsibility of the secretary or authorized representative from each Affiliate Association to complete and return the report. This report includes Member information, meeting dates, scholarships and awards, and other significant activities of your Affiliate.

One purpose of the report is to ensure proper and accurate information for publications and contact lists. It also helps the office stay in touch with each Affiliate and pass along timely information. It's important that we have your Affiliate's Executive Board CURRENT contact information so we can send newsletters, updates, and other information.

Another reason each Affiliate is asked to complete the report is for the Affiliate Awards given at the IAFP Annual Meeting. Awards are given for Best Communication Materials, Best Educational Conference, Best Annual Meeting, Affiliate Membership Achievement Award, and the C.B. Shogren Memorial Award for the Affiliate demonstrating exceptional overall achievement in promoting the mission of IAFP. Award selection is decided largely on the information presented in your report.

To assist in providing information for each award, we've included the descriptions on page 8. With updated information, we can promote your events, honors, and scholarships.

Annual reports must be received in the IAFP office no later than Monday, March 13, 2006. Reports may be E-mailed to affiliate@foodprotection.org, faxed to 515.276.8655, or mailed to the Association office. A copy of all completed reports will be forwarded to the Awards Committee for consideration. Those selected for awards will be notified in April. Awards will be presented at the IAFP Awards Banquet in Calgary, Alberta, Canada on Wednesday, August 16.

Affiliate Awards and Recognitions

C.B. Shogren Memorial Award - The C.B. Shogren Memorial Award is given annually to the Affiliate demonstrating exceptional overall achievement in promoting the mission of the International Association for Food Protection. The award consists of a plaque and a \$100 honorarium. It is sponsored by the International Association for Food Protection. Affiliates who submit an Annual Report will be

judged on their activities and meetings, communications, number of members, Web site, scholarships and awards supported, and membership promotions.

The C.B. Shogren Memorial Award is given in honor of a long-time Member of IAFP, C.B. Shogren. Mr. Shogren was awarded an honorary life membership in 1964 and has been honored in namesake by the C.B. Shogren Memorial Award since 1972. He served as a top executive at Klenzade Products, Inc. until his retirement and was often called upon to solve problems confronting sanitarians. He was a consistent Annual Meeting attendee.

Best Affiliate Educational Conference Award - The International Association for Food Protection's Best Educational Conference Award is given annually to the Affiliate contributing to the education of its members with a technical meeting(s) on topics pertinent to the interests of its membership. The award consists of a mounted certificate. The committee will judge information and material deemed to reflect educational meetings, and submitted as part of the Affiliate's Annual Report.

Best Affiliate Annual Meeting Award - The International Association for Food Protection's Best Affiliate Annual Meeting is given annually to the Affiliate hosting a comprehensive annual meeting covering a wide variety of issues and topics of interest to its membership. The award consists of a mounted certificate. The committee will judge the quality of the Affiliate's annual meeting based on information and material submitted as part of the Affiliate's Annual Report.

Best Affiliate Communication Materials Award - The International Association for Food Protection's Best Affiliate Communication Materials Award is given annually to the Affiliate distributing communication materials on a regular basis with good technical content and attractive layout. The award consists of a mounted certificate. The committee will judge the Affiliate's communications based on information and samples of their written communications submitted as part of the Affiliate's Annual Report. If they have one, the Affiliate's Web site will also be viewed and evaluated as a communications tool.

Affiliate Membership Achievement Award - The Affiliate Membership Achievement Award will be given annually to an Affiliate demonstrating aggressive and innovative plans and ideas to recruit new members to join its Affiliate organization with the goal of growing from within. It is not necessary for new Affiliate members to join the International Association for Food Protection, although that is desirable.

Award recipients will be selected by a selection committee consisting of the chair, past chair, and secretary of the Affiliate Council.

International Association for Food Protection Executive Board Speaker Program Guidelines for Affiliates

1. IAFP Board Members are available to speak at Affiliate meetings on numerous topics involving food safety.
2. Each Affiliate may request one Executive Board speaker for one Affiliate meeting within a 12-month calendar year.
3. A minimum of 15 minutes should be allowed for the Board Member to deliver information about the International Association for Food Protection in addition to their main subject(s) (see #1).
4. IAFP will pay the Board Member's expense to travel to the Affiliate meeting location.
5. The Affiliate covers local expenses, including meals, lodging, and local transportation for the Board Member.
6. The Board Member makes their own travel reservations and will submit an expense report to the IAFP office within 10 days of completion of their travel to the Affiliate meeting. Any local expense (see #5) will be billed to the Affiliate.
7. A two-month advance notice is required.
8. To invite a Board Member to speak at your Affiliate meeting, contact Nancy Herselius, Affiliate Council Staff Liaison, for additional details (800.369.6337 or 515.276.3344 or E-mail nherselius@foodprotection.org).

Scientific Brief - Perspectives on Avian Influenza Risk Management for Food Safety Professionals
