



The Arkansas Association for Food Protection (AAFP) held its Annual Educational Conference at the Town Center

in Fayetteville September 12–14, 2022. Achieving much better traffic than the year prior with the pandemic waning, 90 people supported the Affiliate by attending in person. The Planning Committee would like to thank those who attended, along with the 22 vendors that registered for exhibits and the 10 corporate sponsors that helped sponsor poster prizes, food and beverages, and door prizes.

The meeting featured a student poster competition with students from the University







of Arkansas – Fayetteville and Kansas State University. The poster session included 18 competition

posters and one non-competition poster, with prizes awarded in six different categories. The



educational portion of the meeting included seminars on a variety of topics presented both in person and virtually.

Day Two's technical sessions included presentations on ecommerce food safety

challenges; how emerging trends in humanizing pet food has impacted pet food safety and quality; and clean label antimicrobial development, as well as a session on controlled environment agriculture. The morning capped off with a session on how the FDA will look to regulate hormones and drug residues in food.

Afternoon sessions included auditing innovations; managing food safety during a merger; food defense in the face of natural disasters; developing a company culture of food safety; and how to better educate consumers on food safety. The day ended with the always popular networking reception on the terrace, where attendees mingled over great



food and drinks provided by meeting sponsors.



Day Three's sessions included industry updates on beef and pork; FDA updates; USDA FSIS updates; Salmonella stereotyping

and quantification in poultry; predictive food and beverage development with AI; and foreign material inspection services. Closing remarks were then made by Jennifer Acuff, incoming President.

AQIA's Annual General Assembly, a visit to the Institute of Nutrition and Functional Foods (INAF) at Laval University, and a networking cocktail reception were also part of this meeting on September 15.

### New York State Association for Food Protection Holds 99th Conference Reported by Charles Lindberg, Newsletter Editor



Approximately 100 Members, speakers, and guests attended the 99th Annual Conference of the New York State Association for Food Protection (NYSAFP) in East Syracuse

September 20–22, 2022 in person for the first time since September 2019. (Due to the pandemic resulting in part to travel and meeting restrictions, the annual meetings in 2020 and 2021 were held virtually.) This year's meeting was a welcome return to normalcy as attendees were able to take part in 18 presentations over three days and enjoy receptions, exhibitor displays, luncheons, and a hospitality room which have all been an integral part of our annual conferences.

The event kicked off the first evening with a cocktail reception and presentation by Dr. Samuel Alcaine, Cornell University Professor and President of Norwhey Inc., who explained the development and marketing efforts behind the company's whey-based hard seltzers. During the presentation, audience members had the opportunity to sample and comment on the various seltzer flavors.

Day Two's General Session opened with the Presidential Address from Kelly Natali, followed by Mateen Pouyfar, Eat Seedly Co., who presented "Creating and Marketing Nutritious Foods with Hemp Seed." Next, Zahan Mistry, FBI, and Kevin Buttenschon, New York State Police, both spoke on "Transportation Food Safety and Security." Anika Gianforte, Cornell Cooperative Extension, followed with her presentation, "FDA Intentional Adulteration Rule."



### **United Kingdom Association for Food Protection: Nearly 150 Attend Annual** Conference

United Kingdom Association for Nearly 150 food and Food Protection beverage industry professionals came

together at the 19th annual United Kingdom Association for Food Protection (UKAFP) on November 16, 2022 in Cardiff at the All Nations Centre. The conference was organized by Cardiff Metropolitan University's ZERO2FIVE Food Industry Centre.

Attendees heard from a variety of high profile food safety experts, including Nathan Barnhouse and Robin May, both from the Food Standards Agency, who spoke about the organization's role in a changing food system.

Other speakers included John Holah, Kersia Group, Kersia, UK, and UKAFP President, who shared insights on the growing influence of hygienic design in food safety; and Deb Smith, Global Hygiene Specialist, Vikan, who spoke about the latest challenges and solutions in allergen management. Carol Wallace, Professor, University of Central Lancashire, talked about HACCP, and Sarah Hall, SALSA Technologies, presented "Issue 6 Key Changes - Allergens, HACCP and Food Safety Culture 'Success with SALSA.'"

Richa Bedi-Navik, Senior Global Standards Manager, BRCGS, the largest global food safety standard used in more than 130 countries, updated attendees on recent changes which formed part of its recently launched Issue 9. "One of the core themes of the new issue of the BRCGS Global Standard is the importance of developing a positive food safety culture and ensuring its role in effective implementation of food safety management systems, which in turn help to prevent product safety incidents."

David Lloyd, Director, ZERO2FIVE Food Industry Centre, Cardiff Metropolitan University and UKAFP Secretary, stated: "The UK's food and drink safety landscape has seen many changes over recent years, including the impact of the UK's departure from the EU in 2020, the COVID-19 pandemic, an acceleration in the pace of new technologies which have shifted the way people are buying food, an increase in the awareness of the impact of food production on our planet, and growing concerns around food affordability and its nutritional content.

"Each of these factors affects operating models, supply chains, and the workforce. As food safety professionals, it's important for us to come together to discuss how we can respond to a constantly evolving food safety landscape and plan for a sustainable, healthy, and safe future for consumers."

A number of posters were also presented, looking at topics such as hand hygiene at a sandwich factory, milking practices on dairy farms, food safety information in meal kit recipes, and Food Hygiene Rating Scheme (FHRS) inspection reports.
